## CHAPTER 1973-18

No. 244 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1972-32 APPROVED JUNE 23, 1972 BY APPROPRIATING THE SUM OF ONE HUNDRED SIXTY SEVEN THOUSAND (\$167,000) DOLLARS TO VARIOUS ITEMS IN VARIOUS WATER DEPARTMENTS.

Approved May 14, 1973

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1972-32 of the Ordinances of the City of Providence, as approved June 23, 1972, entitled: "An Ordinance Making Appropriation of \$76,070,746.51 for the Support of the City Government for the Fiscal Period Beginning July 1, 1972 and Ending June 30, 1973", as amended, is hereby further amended by appropriating the sum of One Hundred Sixty Seven Thousand (\$167,000) Dollars as follows:

1. 81-03 - Item 7 (721) - Water-Transmission and Distribution
2. 81-02 - Item 2 (231) - Water-Source of Supply
3. 81-09 - Item 3 - Water-Taxes

SECTION 2. The said sum of One Hundred Sixty Seven Thousand (\$167,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer One Hundred Sixty Seven Thousand (\$167,000) Dollars from Water-Transmission and Distribution-Water Depreciation and Extension Fund to the Receipt Account.

SECTION 3. This Ordinance shall take effect upon its passage.
