CHAPTER 1974-10

No. 143 **AN ORDINANCE** Amending Chapter 1044 of the Ordinances of the City of Providence, Approved July 12, 1956, entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for West River Project, No. UR R.I. 1-6".

Approved March 22, 1974

Be it ordained by the City of Providence:

1. That Chapter 1044 of the Ordinance of the City of Providence, entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the West River Project No. UR R.I. 1-6" as heretofore amended, be and is hereby further amended as follows:

Regulations and Controls to be Applied

g. Sign Regulations

Delete Section g. (4) - Sign Dimensions in Page 14 of the Official Redevelopment Plan and insert the following instead:

g. (4) Sign Dimensions - Wall signs and parapet signs shall have a maximum area of not more than three square feet for each running foot of the face of the building displaying such sign; and a maximum projection of not more than 12 inches from the face of the building.

Plaques shall have a maximum area of eight (8) square feet.

Insert g. (6) following g. (5):

g. (6) Additional regulation - In addition to the above sign controls, the Agency in its sole and absolute discretion shall have the final right of approval or rejection.

2. That said Chapter 1044 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That the ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

Enclosed is an Ordinance (original and 9 copies) which should be submitted in place of the Ordinance transmitted to the City Clerk's Office on January 11, 1974 and introduced to the City Council on January 17, 1974.
