Dollars for the repair, reconstruction and replacement of the sewage treatment plant of the City of Providence, substantially in accordance with the accompanying draft act.

**AUTHORIZING THE CITY OF PROVIDENCE TO ISSUE BONDS IN A SUM NOT EXCEEDING THREE MILLION FIVE HUNDRED THOUSAND (\$3,500,000.00) DOLLARS FOR THE IMPAIR, RECONSTRUCTION AND IMPROVEMENT OF THE SEWER TREATMENT PLANT OF THE CITY OF PROVIDENCE**

It is enacted by the General Assembly as follows:

**SECTION 1.** The City of Providence is hereby authorized and empowered, in addition to and not in substitution for authority previously granted, to issue, in addition to the bonds heretofore issued and now outstanding, under its corporate name and seal, serial bonds in any form which the City Council of said City has heretofore approved, or may approve, in a sum not exceeding three million five hundred thousand (\$3,500,000.00) dollars. Said bonds shall be in any denomination not exceeding twenty thousand (\$20,000.00) dollars each, shall bear interest at a rate not exceeding (3½) percentum per annum, payable semi-annually; the principal thereof and the interest thereon shall be payable in any coin or currency of the United States of America which at the time of payment is legal tender for public and private debts, and the debts incurred by said bonds shall be obligatory on said City in the same manner and to the same extent as other debts lawfully contracted by said city. The dates of maturity of said bonds shall in no case be more than twenty-five (25) years after date of issue and not less than three and one-half per cent nor more than six and one-half percent of the principal amount of said bonds issued shall become due and payable in any one year; provided, however, that the first instalment of the principal of the bonds issued

under the provisions of this act shall mature on such date as the City Council of said City shall determine, but not later than five years after the date of issuance.

Sec. 2. Said bonds shall be signed by the city treasurer and countersigned by the mayor of the city of Providence, and shall be issued and sold at such times and in such amounts as the city council of said city shall determine; provided, however, that the premiums, if any, arising from the sale of said bonds shall be applied to the payment of the principal of said bonds in the order of their maturity. The proceeds arising from the sale of the bonds authorized by this act shall be delivered to the city treasurer, and such proceeds, except as heretofore provided in respect to the premiums arising from the sale thereof, shall be expended for the repair, reconstruction and replacement of the sewage treatment plants of the city of Providence.

Sec. 3. The City of Providence shall annually appropriate a sum sufficient to pay the interest upon the bonds issued and outstanding under the authority of this act, and also to pay the principal of the bonds maturing in any such year, until said bonds are paid in full. All obligations of said city which are incurred under authority of this act shall be exempted from the operation of section 25 of chapter 329 of the general laws of 1930.

Sec. 4. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed, said city of Providence having been authorized to issue these bonds in a sum not exceeding three million five hundred thousand (\$3,500,000.00) dollars at the general election held November 6, 1932.

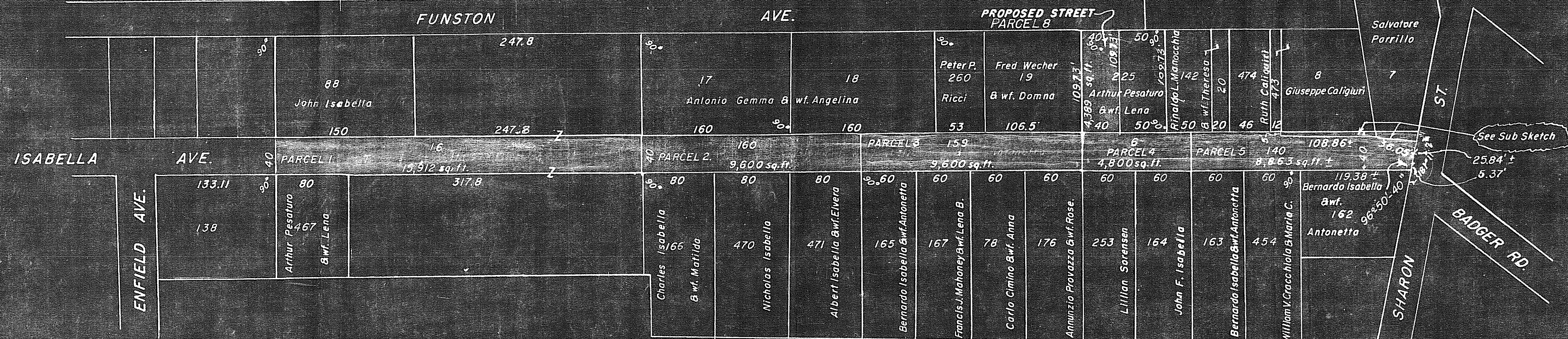
ACCEPTING DEEDS FROM TOMASSO

# RESOLUTION OF THE CITY COUNCIL

No. **105**

Approved February 6, 1953

**Whereas,** the McCarran-Walter Immigration Law has aroused considerable protests in this country and in all other democratic countries in Europe and other parts of the free World because of its inhuman prejudices and discriminating provisions, and

WHEREAS, both candidates for the Presidency of the United States, before election, had advocated the revision of the present Act, and

WHEREAS, the report of the Commission appointed by former President Harry S. Truman has called for complete revision of the existing Act which would abolish the quota system and admission of 100,000 additional aliens subject to the United States requirements and qualifications, and

WHEREAS, the present Act is anti-Catholic, anti-Protestant and anti-Jewish and if the Commissioners' report was enacted into law by Congress, it would convince the free peoples of this world that we still have faith in the great principles upon which this Nation was founded and prospered,

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Providence urgently request the Members of Congress from the State of Rhode Island to urge passage and vote for those Acts which have been presented to the Congress of the United States by Representatives Celler and Javits.


