




Oxford Street, from Gordon Avenue to Prairie Avenue;



Re: St. Michaels Community Festival

Dear Councilman Rollins,

I have been asked by the Committee for the St. Michael's Community Festival to contact you to request that you sponsor a resolution that will authorize the closing of streets in the immediate vicinity of St. Michaels Church on Oxford Street. The Community Festival is an annual event sponsored by the Church to celebrate the feast of St. Michael and to celebrate the South Providence Community generally.

Gordon Ave: from Oxford St. to Sayles St.


Croyland Road: from Oxford St. to Sayles St.
