RE: PENDING MATTERS

Request: That the Traffic Engineer is requested to cause the installation of No Parking to Corner signs at the intersection of Humboldt Avenue and Wayland Avenue.

Disposition: The curbs will be painted yellow. This is the first step, if this does not remedy the situation – signs and posts will be installed. I feel that the installation of posts and signs will create "sign pollution" to this neighborhood. Usually, most people honor the yellow marking as opposed to signs.
