Gentlemen:


The subject petition from the Providence City Council Committee on Public Works proposes the street betterment of that portion of Lakeview Drive from 40 feet south of Westmore Street to Molter Street. The proposed street betterment consists of installation of curbstones and paving of gutters. This petition was submitted by Benjamin Carbone at 141 Lakeview Drive, Providence, Rhode Island.

A field inspection revealed that the aforesaid portion of Lakeview Drive was paved with asphalt recently and has a centerline length of approximately 141 feet. The petitioner, Mr. Carbone owns a single family house at the westerly side of that portion of the street in question. The major portion of Lakeview Drive from Swanton Street to Westmore Street is improved. There are vacant residential lots on both sides of the remainder of the unimproved Lakeview Drive. There are all single family structures in the surrounding area in good to excellent condition within the R-1 Zone. To improve the aforesaid portion of Lakeview Drive, it will not only provide public services to the property owners but also encourage future home owners to build on those vacant lots. Therefore,
