No. 318 AN ORDINANCE REQUESTING THE SECRETARY OF STATE TO SUBMIT THE FOLLOWING QUESTIONS TO THE VOTERS AT THE SPECIAL ELECTION TO BE HELD ON TUESDAY, JUNE 2, A. D. 1964.

*Be it ordained by the City of Providence:*

SECTION 1. The Secretary of State is hereby requested to submit the following questions to the qualified electors of the City of Providence at the Special Election to be held in said City on Tuesday, June 2, A. D. 1964, namely:

1. Shall Chapter 81 of the Public Laws of Rhode Island, 1964, be approved, and the City of Providence be authorized to issue bonds in a sum not exceeding One Million Two Hundred Thousand (\$1,200,000) Dollars for repair, maintenance, replacement and reconstruction of public bridges, as provided in said act?
2. Shall Chapter 82 of the Public Laws of Rhode Island, 1964, be approved, and the City of Providence be authorized to issue bonds in a sum not exceeding Three Hundred Thousand (\$300,000) Dollars for sewer purposes, as provided in said act?
3. Shall Chapter 83 of the Public Laws of Rhode Island, 1964, be approved, and the City of Providence be authorized to issue bonds in a sum not exceeding Five Hundred Thousand (\$500,000) Dollars for highway purposes, as provided in said act?

4. Shall Chapter 84 of the Public Laws of Rhode Island, 1964, be approved, and the City of Providence be authorized to issue bonds in a sum not exceeding Four Hundred Thousand (\$400,000) Dollars for the maintenance, repair and modernization of Public Works--Sanitation Division Buildings and Equipment, as provided in said act?
  
5. Shall Chapter 155 of the Public Laws of Rhode Island, 1964, be approved, and the City of Providence be authorized to issue bonds in a sum not exceeding One Million Five Hundred Thousand (\$1,500,000) Dollars for school modernization and/or construction, as provided in said act?

SEC. 2. The City Clerk is directed to transmit to the Secretary of State forthwith upon the passage of this Ordinance, a certified copy thereof.

SEC. 3. This Ordinance shall take effect upon its passage and all Ordinances and Resolutions and parts of either inconsistent herewith are hereby repealed.

SECTION 1. 

SECTION 1. Chapter 1565 of the Ordinances of the City of Providence, as approved September 24, 1963 entitled: "An Ordinance Making Appropriation of \$44,468,244.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1964", as amended, is hereby further amended by appropriating the sum of Seventy Five Hundred (\$7500) Dollars to an Account to be known as, "ROGER WILLIAMS PLAT WATER SERVICE ACCOUNT".

SECTION 2. The said sum of Seventy Five Hundred (\$7500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Seventy Five Hundred (\$7500) Dollars.

SECTION 4. The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to an account in the Revolving Funds to be known as, "Roger Williams Plat Water Service Account". Any balance remaining in this account upon completion of this work shall revert to the General Fund. Receipts received from property owners connecting to this service shall be paid to the Revolving Fund from which they shall be paid to the General Fund Revenue.

SECTION 5. This ordinance shall take effect upon its passage.


SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by One Hundred Thousand (\$100,000) Dollars.


