## ORDINANCE(S) SECOND READING

**The Following Ordinances were in City Council March 21, 2024, Read and Passed the First Time and are Returned for Passage the Second Time:**

**COUNCILMAN TAYLOR, COUNCILWOMAN PETERSON, COUNCIL PRESIDENT MILLER, COUNCILMAN ESPINAL, COUNCILWOMEN GRAVES, HARRIS AND COUNCILMAN VARGAS, (By Request):**

An Ordinance Amending Chapter 21 "Revenue and Finance", of the Providence Code of Ordinances, to add Article XVIII, "Tax Amnesty Period."

WHEREAS, The State of Rhode Island adopted R.I. General Laws § 44-5-88, enabling City Councils to adopt, by Ordinance, the terms of a local tax amnesty period for the collection of delinquent tangible personal property and motor vehicle tax bills.

*Now Therefore, Be it ordained by the City of Providence:*

Section 1. Chapter 21, "Revenue and Finance," is hereby amended to add Article XVIII, "Tax Amnesty Period" as follows:

21-312. Tax Amnesty

- (a) As authorized in R.I. Gen. Laws § 44-5-88, the tax collector is hereby authorized to waive interest and penalties on overdue tangible personal property taxes and motor vehicle taxes during two (2) separate sixty (60) day periods in fiscal year 2024. Any request for a waiver of interest and penalties must be made in writing, signed and dated by the taxpayer and submitted to the tax collector within the waiver periods outlined in subsection (e) below. The tax collector shall provide the form requesting a waiver for interest and penalties on overdue tangible taxes and motor vehicle taxes.

- (b) The decision of the tax collector shall be rendered in writing and contain a notice to the City Council. The tax collector may only approve an application for a waiver of interest and penalties in cases where the taxpayer/applicant has paid in full the principle amount of taxes owed prior to or at the time of the application, providing that they meet the requirements as determined by the tax collector.
- (c) If the taxpayer receives an adverse decision from the tax collector, the taxpayer/applicant shall immediately pay the interest and penalties owed which are the subject of the claim and may within ten (10) business days from the date of the decision, file a claim for reimbursement with the City Council. No such claim shall be granted unless the taxpayer has paid all interest and penalties on overdue tangible taxes and motor vehicle taxes.
- (d) Any request for reimbursement for interest and penalties made to the City Council pursuant to subsection (c) and that is in compliance with the criteria outlined in subsections (a), (b) and (c) above may be granted by the City Council.
- (e) The first fiscal year 2024 sixty (60) day period shall run from May 1, 2024, through and including June 30, 2024.
- (f) No waivers of interest and penalties for any taxes owed in fiscal year 2024 shall be granted.

Section 2. This Ordinance shall take effect upon passage.

**COUNCILMEN GONCALVES, ESPINAL, COUNCILWOMEN HARRIS,

An Ordinance in Amendment of Chapter 15 of the Code of Ordinances of the City of Providence, Entitled: "Motor Vehicles and Traffic," to amend to add Article XXI "Weight Limits."

WHEREAS, Pursuant to R.I.G.L. § 31-25-26, the General Assembly has granted municipalities to prohibit the operation of trucks or other commercial vehicles, or may impose limitations as to the weight of those vehicles on designated highways under their jurisdiction;

NOW, THEREFORE, Be it ordained by the City of Providence:

Section 1. Chapter 15, "Motor Vehicles and Traffic" is hereby amended to add Article XII, "Weight Limits," as follows:

**ARTICLE XII.- WEIGHT LIMITS**

Sec. 15-141. Weight of vehicles on bridges.

No person shall drive or cause to be driven any vehicle upon or across any existing bridge in the city, the gross vehicle weight rating (GVWR) of which vehicle including the load exceeds Fifteen (15) tons. This article does not exempt trucks holding a valid overweight permit issued by the State of Rhode Island.

Sec. 15-142. Weight of trucks on certain streets.

(a) *Definitions.* Within this section:

“Truck” means every vehicle falling within any definition in Rhode Island General Laws §§ 31-1-4 and 31-1-5.

“Weight” means gross vehicle weight.

(b) *Weight limits.* Trucks exceeding the listed weight are prohibited from operating on the following streets between the listed extents:

Street	Extents of Weight Limit	Weight Limit
Angell Street	Benefit Street to Wayland Avenue	15 tons
South Angell Street	Wayland Avenue to Butler Avenue	15 tons
Waterman Street	Benefit Street to Butler Avenue	15 tons
Gano Street	Angell Street to Trenton Street	15 tons
Medway Street	Butler Avenue to Gano Street	15 tons
Butler Avenue	Angell Street to South Angell Street	15 tons
Butler Avenue	Waterman Street to Pitman Street	15 tons

(c) This section shall not apply to:

- (1) Vehicles that are statutorily exempt under R.I.G.L. § 31-25-2;
- (2) School buses, as defined by R.I.G.L. § 31-1-3(aa);
- (3) Vehicles designed and used for the hauling of refuse when hauling refuse;
- (4) Vehicles whose origin or destination abuts the restricted roadway; and
- (5) Vehicles performing maintenance, utility work, cleaning, snow removal, or de-icing in, on, above, and along the restricted roadway.
- (6) Vehicles owned and operated by the State of Rhode Island and City of Providence or vendors contracted by the State of Rhode Island and the City of Providence and being used as a vendor at the time they are traveling on the restricted roadway.

Section 2. Section 23-154, “Weight of vehicles on bridges,” having been transferred to Sec. 15-141, is hereby repealed, except with respect to duties that matured, penalties that were incurred, or proceedings that were begun before the date of enactment of this Ordinance. An offense committed under Sec. 23-154 is deemed to have been taken or committed under Sec. 15-141.

Section 3. Section 15-2, "Penalties for traffic violations," is hereby amended as follows:

(a) *Generally.* The general penalties provided for by section 1-10 of this Code of Ordinances shall apply to violations of this chapter or any regulations made there under except that any person electing to appear before the clerk of court, or mailing the same, in lieu of a personal appearance before the Providence Municipal Court and admitting the violation charged, shall be punished by a fine as hereinafter respectively set forth:

*Offense fine*

- Parking from 2:00 a.m. to 5:00 a.m.\* .....\$20.00
- Overtime parking from 5:00 a.m. to 2:00 a.m. ....20.00
- Parking without permit in a residential zone ....15.00
- Parking at expired meter .....25.00
- Parking during an emergency .....100.00
- Parking so as to obstruct the flow of traffic .....75.00
- Parking in prohibited area (no parking) .....30.00
- Parking within eight (8) feet of fire hydrant .....100.00
- Parking in loading zone .....30.00
- Parking in taxi stand .....30.00
- Parking within twenty-five (25) feet of corner .....30.00
- Parking to obstruct driveway .....30.00
- Parking within twelve (12) inches of a driveway as measured by a line running along the curb in either direction .....30.00
- Parking on sidewalk .....100.00
- Parking in a bicycle lane .....100.00\*\*
- Standing in prohibited areas .....30.00
- Double parking (more than three (3) feet from curb) .....30.00
- Parking in marked bus stop .....100.00\*\*
- Parking in excess of one (1) foot, but not more than three (3) feet from curb .....30.00
- Parking with left wheels to curb .....30.00
- Angle parking .....30.00
- Parking on marked crosswalk or within intersection .....100.00\*\*

- Stopping bus away from curb .....30.00
- Parking in a tow zone .....100.00
- Violation of moving vehicle traffic regulation .....75.00
- Violation of street or bridge weight limits .....200.00

\* Except in those areas designated as resident permit parking areas (which allow for residential permit parking only between the hours of 2:00 a.m. and 5:00 a.m.).

\*\* The city shall contribute any increase in revenue generated from the increase in fine amounts to smart growth initiatives.

In the event any of the foregoing stated fines are not paid or a plea of not guilty to the citation is entered prior to the fourteenth day after date of violation, said fines shall be doubled.

In the event any of the foregoing stated fines are not paid or a plea of not guilty to the citation is entered subsequent to the fourteenth day and prior to the twenty-eighth day after date of violations, said fines shall be tripled.

*(b) Meter violations.* Where the violation occurs in a metered space it shall be a separate violation for vehicles remained parked in said space for each consecutive unit of time beyond the first unit of time, up to a maximum of two (2) violations.

Section 4. The Department of Public Works is hereby directed to erect signs stating “WEIGHT LIMIT 15 TONS EXCEPT LOCAL DELIVERIES” or a substantially similar message at appropriate locations to carry out the intent of this Ordinance.

***WHEREAS***, The introduction of two-way protected bike lanes, including on South Water Street, has notably resulted in a 10% decrease in fatalities, a 21% decrease in total crashes per year, a 22% decrease in injuries per year, a 55-61% decrease in pedestrian injuries, and a 53-63% decrease in serious injuries, underscoring the significant impact of these lanes on enhancing public safety, as evidenced by an analysis of crash data from 2014-2023; and

***WHEREAS***, During his recent visit to Providence, in a question posted by reporter Bill Bartholomew, United States Transportation Secretary Pete Buttigieg emphasized the importance of such initiatives by stating, "the big picture is we want to make sure we move towards more accessibility and not less, more bike and pedestrian connectivity and not less...I've been talking a lot to the Mayor and his focus about safety...This is really about the safety of getting around our communities in a time when the biggest category contributing to the rise of roadway deaths in recent years has been bike and pedestrian fatalities. Bike infrastructure helps us fight that trend, "highlighting the critical role of bike lanes in combating the increase in roadway deaths; and

***WHEREAS***, On January 14, 2022, the South Water Street bike lanes were recognized as one of the Five Best New Bikeways in the United States by PeopleForBikes.org, a testament to the project's excellence and its contribution to reimagining urban spaces for safer, more sustainable transportation; and

***WHEREAS***, The transformation of South Water Street from a hazardous highway ramp into a pedestrian-friendly Complete Street has dramatically improved the area's safety and livability. This includes traffic calming measures that led to an 84-96% reduction in the rate of vehicles traveling over 30 mph, the installation of new pedestrian crossings connecting to Memorial Park, ADA-compliant designs, and enhanced bus islands, all contributing to a more inclusive and safer urban environment; and

***WHEREAS***, The successful realization of the South Water Street bike lanes stemmed from a broad and inclusive consultation process, involving multiple public meetings and direct feedback from local residents, businesses, and stakeholders. This collective effort addressed concerns from the former two way drag strip, ranging from safety and noise disturbances caused by loud music, street racing, ATVs, altered mufflers, droves of motorcycles, and other activities that detracted from the waterfront's tranquility, to ensuring the preservation of on-street parking vital for local businesses; and

**WHEREAS**, Avid supporters and neighborhood abutters have voiced their concerns over the safety and quality of life along the waterfront, which prior to the bike lane installation, was compromised by dangerous activities and noise pollution. The bike lanes have since fostered a safer, more serene environment, contributing significantly to the community's quality of life; and

**WHEREAS**, Any proposed dismantling of the South Water Street bike lanes runs counter to the principles and objectives of recent city initiatives, such as the groundbreaking of the Woonasquatucket Greenway project and the amendment to the Green & Complete Streets Ordinance, reflecting a city-wide dedication to sustainability, connectivity, and public well-being; and

**WHEREAS**, Any attempt to remove these bike lanes not only undermines the Mayor Smiley's recent commitment to Vision Zero but also risks forfeiting substantial federal and city investments aimed at expanding the urban trail network, thereby affecting job creation, public safety, and overall connectivity.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council stands firmly against the removal of the South Water Street bike lanes, recognizing their indispensable role in enhancing the city's safety, sustainability, and equitable transportation access; and

**BE IT FURTHER RESOLVED**, That the Providence City Council will not and does not support the allocation of Capital Infrastructure Plan funds or any other city funds towards the dismantling of the South Water Street bike lanes, as such actions have not been sanctioned by the Council and directly contradict our city's strategic goals for its transportation infrastructure and environmental policies; and

**BE IT FURTHER RESOLVED**, That, in accordance to the *recently* enacted Green and Complete Streets Ordinance amendment signed into law in December 2023, in which "any removal of complete streets features, or any new construction or improvement of off-road bicycle paths or multi-use trails" must be approved by the Green and Complete Streets Advisory Council, we call upon the Green and Complete Streets Advisory Council to oppose any efforts to remove the South Water Street bike lanes.

**WHEREAS**, The Rhode Island Department of Transportation (RIDOT) announced an unforeseen and immediate closure of the westbound side of the Washington Bridge, significantly disrupting traffic along the I-195 corridor, and

**WHEREAS**, This closure, initiated for structural concerns, has markedly affected local businesses, particularly in areas such as Wayland Square, Hope Street, and Federal Hill, contributing to reduced customer foot traffic and economic hardship for businesses, and

**WHEREAS**, Governor Dan McKee, on March 14, revealed plans for the complete demolition and reconstruction of the I-195 Washington Bridge, a project with an anticipated completion in 2026, extending the period of economic impact on local businesses, and

**WHEREAS**, The U.S. Small Business Administration has acknowledged the economic detriment caused by this infrastructure project, prompting the approval of \$586,200 in Economic Injury Disaster Loans to assist 951 applying businesses across Providence, Bristol, and Kent counties, in addition to businesses in Bristol County, Massachusetts, and Windham County, Connecticut, yet recognizing the need for further support, and

**WHEREAS**, Heather Singleton, Interim CEO of the Rhode Island Hospitality Association, has underscored the vital role of community support in sustaining small businesses during these challenging times.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of Providence hereby urges Governor Dan McKee and the Rhode Island General Assembly to take immediate and comprehensive action to provide grants or reimbursement assistance to business owners for losses incurred due to the Washington Bridge closure and to actively seek additional funding avenues to provide grants for businesses, particularly those in the most affected areas in Providence such as Wayland Square, Hope Street, and Federal Hill etc.

**BE IT FURTHER RESOLVED**, That the City Council calls upon all available resources to be mobilized to support and promote Providence businesses, encouraging both residents and visitors to support the local economy.

**BE IT FURTHER RESOLVED**, That the City Council urges the exploration of all potential funding sources, including state and federal grants, to provide immediate and long-term financial assistance to businesses facing economic hardship as a direct result of the bridge closure and construction project.


