No. 186 AN ORDINANCE IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1979-30, APPROVED JUNE 22, 1979 AS AMENDED, BY APPROPRIATING THE SUM OF FIVE THOUSAND, SIX HUNDRED DOLLARS (\$5,600.00) TO ITEM O, DEPARTMENT OF PUBLIC LANDS AND PARKS - ZOO DIVISION.

Approved April 24, 1980

Be it ordained by the City of Providence:

WHEREAS, That the Zoo opens as expeditiously as possible and that all requirements of the U. S. Department of Agriculture, pursuant to the Animal Welfare Act of 1970, are complied with, and

WHEREAS, To implement the agreements made by His Honor, Mayor Vincent A. Cianci, Jr., with the U. S. Department of Agriculture, with Local Union 1033, with the Rhode Island Zoological Society, Inc., and to protect the Public Safety and Welfare of the Citizens of the City of Providence,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PROVIDENCE,

SECTION 1. Chapter 1979-30 of the Ordinances of the City of Providence as Approved June 22, 1979, Entitled: "An Ordinance Making An Appropriation of One Hundred Seventeen Million, Nine Hundred Seventy-Eight Thousand, Seven Hundred Thirty-Nine Dollars and Forty-Four Cents, (\$117,978,739.44) for the Support of the City Government for the fiscal year ending June 30, 1980, as amended, is hereby further amended and by appropriating the Sum of Five Thousand Six Hundred Dollars, (\$5,600.00) to Department of Public Lands and Parks - Zoo Division.

SECTION 2. This Ordinance shall take effect upon its passage.
