**Section 2** - All funding referenced is subject to American Rescue Plan Act (ARPA) spending guidance. Failure to comply with these regulations will result in a forfeiture of funding allocation.

**Section 3.** – All projects funded through American Rescue Plan Act (ARPA) shall adhere to the City Charter Section 1006 (c), (d), (e), Section 1007 and Code of Ordinances, Chapter 21, Article II.

**Section 4** – All Providence Redevelopment Agency projects funded through the American Rescue Plan Act (ARPA) must exhaust all other available financing options.

**Section 5** – The \$3,000,000 for the Home Repair Program shall be a five-year forgivable loan in amounts ranging from \$5,000 - \$50,000. Eligible properties must:

- a. Be located in the City of Providence;
- b. Have an existing code violation as of the passage of this ordinance;
- c. Household income must be at or below 100% current area median family Income Limits for Low – and Moderate-Income Households;
- d. Homeowners must demonstrate that they have exhausted all funding options to make the repairs to resolve the code violation.

The terms of the loan will be as follows:

- a. No origination fee;
- b. No payment is required as long as the borrower/ homeowner is still residing in the home for 5 years
- c. Construction management is required on all forgivable loans.
- d. Loan will forgive after five years if the property stays eligible. If the borrower sells the property, rents the property to an unrelated party, or has the mortgage foreclosed, the principal balance will be due in full.
- e. Loan will be recorded with a lien on the property, discharged upon maturity.

**Section 6** – The property purchased and rehabilitated through the Facilities Development Program, when sold shall pay any net proceeds to the Providence City Council created Affordable Housing Trust.

**Section 7** – Quarterly audit reports from the independent auditor shall be submitted to the Providence City Council within 30 days of the close of the quarter.

This Ordinance shall take effect upon passage.

Resolution in Support of funding for Providence Promise.

***WHEREAS***, Expanding access to high-quality early education opportunities is essential to improving Providence education; and

***WHEREAS***, Access to high-quality education reduces learning deficits and leads to positive outcomes for students; and

***WHEREAS***, Learning deficits that begin in kindergarten are likely to follow the student through their entire K-12 education, even impacting graduation rates; and

***WHEREAS***, Providence Promise is the only program in Rhode Island focused on early planning for higher education beginning as early as birth through the use of 529 college savings accounts and family engagement; and

***WHEREAS***, Providence Promise is a parent-driven partnership that provides a foundation to support public school students to continue their education after high school; and

***WHEREAS***, The savings accounts established through the program provide essential funding for school and create a family and community expectation that their child will attend an institution of higher education; and

***WHEREAS***, A financial commitment from Providence Public Schools would enable the program to provide a pilot cohort of every Providence kindergartener (1,500 - 2,000 children) with a college savings account, 400 of whom would also be fully enrolled in the Providence Promise program.

***NOW, THEREFORE, BE IT RESOLVED***, That the City Council in conjunction with Providence Mayor Jorge Elorza respectfully requests that Commissioner of Education, Angélica Infante-Green, and Superintendent Dr. Javier Montañez commit to funding the Providence Promise.

***BE IT FURTHER RESOLVED***, That upon passage copies of this Resolution be transmitted to Mayor Jorge Elorza, Commissioner Infante-Green, Superintendent Montañez, and the Providence School Board.

Resolution Endorsing and Urging Passage by the General Assembly of Senate Bill 2022 S-2095, Joint Resolution to Approve, Publish and Submit to the Electors a Proposition of Amendment to the Constitution - Right to an Adequate Education.

**WHEREAS**, In 1993, the Massachusetts Supreme Court found that the Commonwealth had a constitutional duty *“to ensure the education of its children in the public schools.”* and shortly thereafter, the Massachusetts Legislature passed, and Governor William Weld signed the Education Reform Act into law, and also provided an additional \$2 billion in school aid over several years and;

**WHEREAS**, The Massachusetts Reform Act ushered in an era of accountability, and the increase in funding significantly narrowed the achievement gap and;

**WHEREAS**, Since the enactment of the Reform Act, Massachusetts’ students’ performance on national and international assessments annually leads the nation and;

**WHEREAS**, In 1995, the Rhode Island Supreme Court found, in a lawsuit brought by the Pawtucket and Woonsocket school districts, that education is not a guaranteed right and also held that *“... the education clause did not intend to guarantee an “equal, adequate, and meaningful” education because both at the time article 12 was adopted, and for decades afterward, there was no requirement that public education be provided at all in this state.”* and;

**WHEREAS**, In 2014, the Rhode Island Supreme Court reaffirmed their 1995 ruling in a suit again brought by the Pawtucket and Woonsocket, but also stated that *“We emphasize that we are deeply concerned by the conditions of the schools in Pawtucket and Woonsocket...”* and;

**WHEREAS**, We believe Rhode Island has an obligation to provide the resources to guarantee students an equitable, adequate, and meaningful education and;

**WHEREAS**, On March 15, 2022, the Rhode Island Senate unanimously passed Senator Roger Picard’s Resolution 2022 - S 2095 to place a Referendum before the voters in 2022, amending Article XII of Rhode Island’s Constitution by making education a fundamental right and adding *“...it shall be the additional duty of the general assembly and the state to guarantee an equitable, adequate and meaningful education to each child.”* and;

**WHEREAS**, 2022 - S 2095 was referred to the House Committee on State Government and Elections, where Representative Mary Messier has a companion Resolution, and both Resolutions need to be passed by the Committee for consideration by the full House of Representatives.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council hereby respectfully requests the House Committee on State Government and Elections and the Rhode Island House of Representatives pass Senate Bill S - 2095 and its House companion, thus causing a referendum to be placed before the voters, amending Article XII to make education a fundamental right in the State of Rhode Island.
