

RESOLUTION OF THE CITY COUNCIL

No. 11

Approved January 14, 1977

WHEREAS, the proposed new State Inspection Law has resulted in wide spread objections from owners of motor vehicles, not only from the point of inconvenience, but from the additional proposed increase in annual inspection fees, which in many cases, would create an added burden on the finances of certain of our citizens in the State of Rhode Island.

NOW, THEREFORE, BE IT RESOLVED, that the General Assembly is requested to reconsider at its scheduled January, 1977 Session, the Provisions of 31-38-5 of the General Laws of Rhode Island, 1956, as Amended, whereby the Assistant Director of Motor Vehicles is authorized to designate Official Motor Vehicle Safety Inspection Stations, and further to invoke the original program of appointments of inspection stations.




