*Whereas*, the Easton name was not to appear on the political horizon again until 1978, when a neighborhood activist and community organizer, Nicholas W. Easton, first sought elective office, and

*Whereas*, Nicholas W. Easton followed in the family traditions of attending Moses Brown School and Brown University, however, he displayed perception and wisdom which seems to have eluded his honored forbears: he moved to Providence, and became a Democrat, and

*Whereas*, while the public conduct of Nicholas W. Easton might not always be described as "peaceable," "serious" and "sober," he has brought to the political life of the City of Providence a discerning mind, true compassion for the unfortunate, unquestioned moral principles, and dedication to duty which would do his esteemed progenitors proud, and

*Whereas*, his lovely wife Sally and five children are a source of strength and a great deal of pride, supporting and sustaining his many public endeavors, and

*Whereas*, it would appear that the Easton name will again find prominence in Rhode Island history, it is hoped that the Eastons "of Elmwood" will not change their political affiliations again for another three hundred years,

*Now, Therefore, Be It Resolved*, that the members of the City Council of the City of Providence do join with the many friends and supporters of Nicholas W. Easton in wishing him well on the occasion of the testimonial held in his honor on September 29, 1985, and extending heartfelt best wishes for continued success and prosperity, and
