No. 132 AN ORDINANCE REAPPORTIONING THE THIRTEEN WARDS
IN THE CITY OF PROVIDENCE.

Approved April 8, 1970

Be it ordained by the City of Providence:

SECTION 1. The City of Providence is hereby reapportioned into thirteen wards, in accordance with the census authorized by the Resolution of the General Assembly passed at the January Session, 1965, Numbered 43, and entitled "Resolution Evaluating a Special Commission to Draft and Report an Act to Reapportion the General Assembly, and to Perform the Necessary Functions Incident to Drafting such an Act," as amended, and bounded and described as follows:

FIRST WARD

The First Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of Dean Street and Brayton Avenue; thence northerly along Brayton Avenue to West Exchange Street; thence continuing northerly, crossing West Exchange Street and continuing along the northerly extension of Brayton Avenue to the center line of the Penn Central Railroad right-of-way; thence easterly along the Penn Central Railroad right-of-way to the center line of Interstate Route 95; thence northerly along the center line of said Interstate Route 95 to Promenade Street; thence easterly along Promenade Street to Memorial Square; thence easterly through Memorial Square to Washington Place and continuing easterly along Washington Place, crossing North Main Street to Waterman Street and continuing easterly along Waterman Street, crossing Hope Street and Wayland Avenue and continuing easterly along Waterman Street to the Providence-East Providence Boundary Line; thence southwesterly along the Providence-East Providence Boundary Line, crossing Interstate Route 195

The Second Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of Jenckes Street and Pratt Street; thence easterly along Jenckes Street, crossing Prospect Street to Barnes Street and continuing easterly along Barnes Street to Thayer Street; thence northerly along Thayer Street to Hope Street and continuing northerly and northeasterly along Hope Street to Mayflower Street; thence southeasterly along Mayflower Street, crossing Morris Avenue to Vassar Avenue and continuing southeasterly along Vassar Avenue to Elmgrove Avenue; thence northeasterly along Elmgrove Avenue to Rochambeau Avenue; thence northwesterly along Rochambeau Avenue to Lorimer Avenue; thence northeasterly along Lorimer Avenue to Blackstone Blvd.; thence northwesterly along Blackstone Blvd. to Hope Street; thence northerly along Hope Street to the Providence-Pawtucket Boundary Line; thence easterly, southerly and easterly along the Providence-Pawtucket Boundary Line to the intersection of the Providence-Pawtucket and East Providence Boundary Lines; thence southeasterly, southerly and southwesterly along the Providence-East Providence Boundary Line to Waterman Street; thence westerly along Waterman Street, crossing Wayland Avenue and Hope Street and continuing westerly along Waterman Street to Benefit Street; thence northerly along Benefit Street to South Court Street; thence easterly along South Court Street to Wheaton Street; thence

The Third Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of the center line of the Penn Central Railroad right-of-way and the Providence-Pawtucket Boundary Line, north of Smithfield Avenue; thence easterly along the Providence-Pawtucket Boundary Line to Hope Street; thence southerly along Hope Street to Blackstone Blvd.; thence southeasterly along Blackstone Blvd. to Lorimer Avenue; thence southwesterly along Lorimer Avenue to Rochambeau Avenue; thence southeasterly along Rochambeau Avenue to Elmgrove Avenue; thence southwesterly along Elmgrove Avenue to Vassar Avenue; thence northwesterly along Vassar Avenue, crossing Morris Avenue to Mayflower Street and continuing northwesterly along Mayflower Street to Hope Street; thence southwesterly and southerly along Hope Street to Thayer Street and continuing southerly along Thayer Street to Barnes Street; thence westerly along Barnes Street, crossing Prospect Street to Jenckes Street and continuing westerly along Jenckes Street to Pratt Street; thence southerly along Pratt Street to Wheaton Street and continuing southerly along Wheaton Street to South Court Street; thence westerly along South Court Street to Benefit Street; thence southerly along Benefit Street to Waterman Street; thence westerly along Waterman Street, crossing North Main Street to Washington Place and continuing westerly along Washington Place through Memorial Square to Promenade Street and continuing westerly along Promenade Street to the center line of the Penn Central Railroad right-of-way; thence northerly along the Penn Central Railroad right-of-way, crossing Smith Street, Orms Street and Charles Street; thence northeasterly along the Penn Central Railroad right-of-way to its intersection with the Providence-Pawtucket Boundary Line north of Smithfield Avenue and the point and place of beginning.

FOURTH WARD

The Fourth Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of Admiral Street and the Providence-North Providence Boundary Line; thence running in a northeasterly, easterly, and southeasterly direction along said boundary line to the center line of the Penn Central Railroad right-of-way, north of Smithfield Avenue; thence southwesterly along said center line of

SIXTH WARD

The Sixth Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of the Providence-Johnston and North Providence Boundary Lines; thence northeasterly along the Providence-North Providence Boundary Line to its intersection with Smith Street; thence southeasterly along Smith Street to Mount Pleasant Avenue and continuing southeasterly and southerly along Mount Pleasant Avenue to Chalkstone Avenue; thence easterly along Chalkstone Avenue to Academy Avenue; thence southerly along Academy Avenue to Regent Avenue; thence easterly along Regent Avenue to Huron Street; thence southerly along Huron Street to Maplehurst Avenue; thence easterly along the extension of Maplehurst Avenue to Allston Street; thence southerly along Allston Street to Cliff Street; thence easterly along Cliff Street to Valley Street; thence southwesterly along Valley Street, crossing Atwells Avenue and continuing southwesterly to Barstow Street; thence southwesterly and westerly along Barstow Street to Cutler Street; thence southerly along Cutler Street to

The Seventh Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of Killingly Street and the Providence-Johnston Boundary Line; thence easterly and northerly along said Providence-Johnston Boundary Line to a point of intersection of said boundary line and the center line of the Penn Central Railroad right-of-way; thence generally southeasterly along said right-of-way, crossing Hartford Avenue to Plainfield Street; thence southwesterly along Plainfield Street to Pocasset Avenue and continuing southwesterly along Pocasset Avenue to Bancroft Street; thence southeasterly along Bancroft Street to Sterling Avenue; thence easterly along Sterling Avenue to Whitehall Street; thence southeasterly along Whitehall Street, crossing Union Avenue and continuing southeasterly along Whitehall Street to its intersection with the Providence-Cranston Boundary Line at Hillwood Street; thence westerly along said boundary line to a point in the Pocasset River in the range of Cavallatti Street; thence continuing generally westerly and northwesterly along the Providence-Cranston Boundary Line and the Providence-Johnston Boundary Line to the northwesterly line of Plainfield Street; thence southwesterly along the northwesterly line of Plainfield Street and the Providence-Johnston Boundary Line and following said boundary line along and around Neutaconkanut Hill Park to Sunset Avenue; thence continuing northwesterly and easterly along said Providence-Johnston Boundary Line to Killingly Street and the point and place of beginning.

NINTH WARD

The Ninth Ward of the City of Providence shall consist of all that part of the City bounded by a line beginning at the point of intersection of Elmwood Avenue and Public Street; thence northeasterly along Public Street to Broad Street; thence southeasterly along Broad Street to Morton Street; thence easterly along Morton Street to Eddy Street; thence northerly along Eddy Street to New York Avenue; thence easterly along New York Avenue to Virginia Avenue; thence southerly along Virginia Avenue to the Providence-Cranston Boundary Line; thence westerly, southerly, southeasterly and generally southwesterly along said boundary line to the northerly line of Park Avenue; thence westerly, northwesterly, northerly and westerly, crossing Interstate Route 95 and continuing westerly along the Providence-Cranston Boundary Line to Reservoir Avenue; thence northeasterly along Reservoir Avenue to Elmwood Avenue; thence northerly along Elmwood Avenue to its intersection with Public Street and the point and place of beginning.

SEC. 2. It shall be understood and intended that in bounding and describing the said Wards, that the said boundary lines of streets, streams, rivers and railroads is meant in all instances the central line of such street, stream, river or railroad, unless the same shall be otherwise specified.

SEC. 3. This Ordinance shall take effect upon its passage, and all ordinances or parts of ordinances inconsistent herewith are hereby repealed.


Will you please introduce the following resolution at the first meeting in April:

WHEREAS, death has taken Valentine H. Mariani, late Member of the Board of Aldermen, from the former Third Ward, during January 3, 1927 to January 7, 1929, and a Member of the City Council from the Fourth Ward, during January 6, 1941 to January 5, 1953, at which time he retired voluntarily, and

WHEREAS, "Val" Mariani, a native and life long resident of Providence, earned a degree in Civil Engineering from Rhode Island State College and later became associated in his family's business as a funeral director, and
