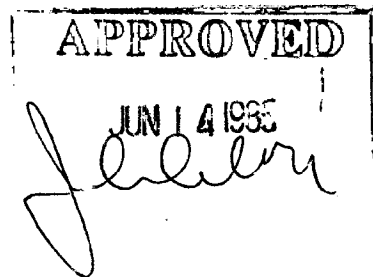

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 5-22-6 of the General Laws in Chapter 5-22  
2 entitled "Shows and Exhibitions" is hereby amended to read as follows:

3 5-22-6. Sunday activities in Providence. -- The bureau of  
4 licenses of the city of Providence may license public automobile  
5 shows, ice skating, ice polo, roller skating, wrestling and hockey  
6 games in rinks and halls between the hours of 2 p.m. and midnight on  
7 the first day of the week.

8 SECTION 2. This act shall take effect upon passage.
