ORDINANCES SECOND READING

The following Ordinances were in City Council September 15, 1977, Read and Passed the First Time and Are Returned for Passage the Second Time:

An Ordinance Creating the "Market Square Pedestrian Mall" upon that portion of Westminster Street, beginning at the Intersection of South Water Street and continuing from the Intersection of South Water Street and the Providence River to include Three (3) Traffic Islands over the Providence River.

Be it ordained by the City of Providence:

Section 1. The Code of Ordinances of the City of Providence is hereby amended to add the following sections: 23-88 to 23-92.

Section 23-88 Established, limits fixed

The City Council hereby establishes, under the authority of Chapter 176, Public Laws of Rhode Island of 1962, a Pedestrian Mall within the Central Business District of the City as shown on the map entitled, "Market Square Pedestrian Mall, Limits of Construction" filed in the Department of City Clerk and as hereinafter generally described:

a. Streets. That portion of Westminster Street, beginning at the intersection of South

Main Street, thence westerly to the intersection of South Water Street and continuing from the intersection of South Water Street and the Providence River to include the three (3) traffic islands over the Providence River.

b. Intersections. The mall intersections and intersecting streets as indicated on the aforementioned map. (Ordinance 1963, Chapter 1563, Section 2.)

Section 23-89. Operation of vehicular traffic restricted.

Vehicular traffic shall be prohibited, in whole, all vehicular traffic on the pedestrian mall with the sole exception of emergency vehicles.

Section 23-90. Towing of unlawfully parked or standing violations.

Any vehicle either parked or left standing in violation of the City Ordinance shall be towed away by any authorized towing agency at the expense of the owner. Fees chargeable shall be as set forth in Section 15-22 of this Code of Ordinances (Ordinance 1963, Chapter 1563, Section 5).

Section 23-91. Interpretation of provisions, reservations of rights to City.

The City and the City Council thereof shall retain its police powers and other rights and powers relating to the City streets constituting a part of the pedestrian mall. No action taken herein shall be interpreted or construed to be a vacation or abandonment, in whole or in part, of any City street or right therein, it being intended that the establishment of a pedestrian mall pursuant to Chapter 176 of the Public Laws of Rhode Island, 1962, be a matter of regulation. Nothing in this article shall be interpreted or construed to prevent the City and City Council, at any time, from changing the extent of this pedestrian mall, or from changing or repealing any of the rules and regulations pertaining to this pedestrian mall.

Section 23-92. Maintenance Responsibilities.

The City Council therefore authorizes the Board of Park Commissioners to be responsible for all necessary care and maintenance requirements of this Mall and to enter into agreements with the Rhode Island School of Design for the programming and maintenance of this mall.

Section 2. This Ordinance shall take effect upon its passage.

An Ordinance requiring the Rhode Island Public Transit Authority to provide Liability Insurance Coverage on its Bus Shelters indemnifying the City of Providence Against Any Claims for Injuries and/or Damages.

Be it ordained by the City of Providence:

Section 1. The Rhode Island Public Transit Authority shall provide liability insurance coverage for bodily injury and property damage on its bus shelters, it has placed and may cause to be placed on any public way in the City of Providence indemnifying the said City against any claims of injuries and damages resulting from such placement of said shelters; the limits of liability for such bodily injury and property damage shall be not less than Three Hundred Thousand Dollars (\$300,000.00) for each occurrence and Three Hundred Thousand Dollars (\$300,000.00) in the aggregate and be approved as to form, by the Acting City Solicitor.

Section 2. This Ordinance shall take effect upon its passage.

1977, by Appropriating the Sum of Seven Thousand, Three Hundred Forty-Five Dollars (\$7,345.00) to the Office of Civil Defense Preparedness Agency, Payroll Account (1-09-07-000).

Be it ordained by the City of Providence:

Section 1. Chapter 1977-35, approved July 18, 1977, and entitled, "An Ordinance in Amendment of Chapter 1977-29, Effective July 11, 1977, Making Appropriation of \$108,255,372.79 for the Support of the City Government for the Fiscal Year Ending June 30, 1978, as Amended, is hereby further amended by appropriating the sum of Seven Thousand, Three Hundred Forty-Five Dollars (\$7,345.00) to the Office of Civil Defense Preparedness Agency.

Section 2. The said sum of Seven Thousand, Three Hundred Forty-Five Dollars (\$7,345.00) as added and appropriated shall be charged to Civil Defense Preparedness Agency, Payroll Account (1-09-07-000).

Section 3. This Ordinance shall take effect upon its passage.

Resolved, That this Minute on the Life and Character of Joseph C. Keegan, late Finance Director of the City of Providence, Rhode Island, who died October 3, 1977, be adopted.

Joseph C. Keegan was a native of the City of Providence which he served faithfully for more than One Quarter of a Century in several Official Capacities.

He attended public schools and graduated in 1929 from the Providence Branch of Northeastern University and upon completion, did Post-graduate work at Northeastern and Boston Universities in Boston, following which he held accounting positions with several private firms and with the State Unemployment Compensation Board before joining the City of Providence's Auditor's Staff in the early 1940's.

He became First Deputy City Auditor in 1943 and Auditor in 1944, at which time he devised the City Budget procedures which were still in use upon his retirement. He remained in that position until 1964, the title being changed to City Controller in 1945; in 1964 he became Finance Director until his retirement in June of 1970.

His ability brought praise and professional awards from all parts of the Country, from all who were made aware of his accomplishments.

Joseph C. Keegan, a humble man, was a Citizen of our Community who enjoyed the respect of all with whom he came in contact; and as a husband, parent, and devoted family man, he gained additional admiration.

In noting the passing of Joseph C. Keegan, the City Council of the City of Providence pauses to honor his memory and the City Clerk is directed to transmit a duly engrossed copy of this Resolution to his bereaved widow, Mary A. Keegan, and to his sons Joseph C. Keegan, Jr. and Robert M. Keegan.
