Resolved,

That the City Treasurer, acting under the direction of the Committee on Finance, be and he hereby is authorized and directed to borrow from time to time such sums as may be necessary, not exceeding three million five hundred thousand (\$3,500,000) Dollars, in accordance with the provisions of Chapter 3049²² of the Public Laws, passed by the General Assembly at its January Session, A.D. 1953, entitled "An Act Authorizing the City of Providence to Issue Bonds in a sum Not Exceeding Three Million Five Hundred Thousand (\$3,500,000) Dollars for the Repair, Reconstruction and Replacement of the Sewage Treatment Plant of the City of Providence," and to issue the City's notes therefor, bearing interest at a rate not exceeding three and one-half (3½) percent per annum, signed by him and countersigned by the Mayor and Chairman of the Committee on Finance, and to renew any such notes from time to time as the same become due. The money thus obtained is hereby appropriated for and shall be exclusively used and expended for the purposes of the repair, reconstruction and replacement of the Sewage Treatment Plant of the City of Providence.



A G R E E M E N T

THIS AGREEMENT made and entered into this 20th day of APRIL, A. D. 1953, by and between the CITY OF PROVIDENCE, a municipal corporation in the County of Providence and State of Rhode Island, created by the General Assembly of said State, and the CITY OF CRANSTON, a municipal corporation in the same County and State, for the disposition of sewage of the City of Providence by means of the sewer system of the City of Cranston, and for the disposition of sewage of the City of Cranston by means of the sewer system of the City of Providence the Mayor of the City of Providence having been authorized to enter into this Agreement by resolution of the City Council numbered 380, approved April 17, A. D. 1953, and the Mayor of the CITY OF CRANSTON having been authorized to enter into this agreement by resolution numbered 81, approved March 24, A. D. 1953.

W I T N E S S E T H:

That the parties hereto, in consideration of the mutual covenants and agreements herein contained, mutually covenant with each other as follows:

FIRST: The City of Providence, for itself and its successors, hereby covenants and agrees with the City of Cranston and its successors, that it will take and admit domestic sewage into its sewer system from houses located in the City of Cranston near the boundary line of said cities, wherever the Director of Public Works of the City of Providence and the Commissioner of Public Works of the City of Cranston shall agree that it is impractical to connect said houses to the City of Cranston sewer system, and the City of Providence at its own expense will dispose of such sewage by means of its sewage disposal plant at or near Fields Point in said city, or otherwise.

SECOND: The City of Cranston, for itself and its successors, hereby covenants and agrees with the City of Providence and its successors, that it will take and admit domestic sewage into its sewer system from houses located in the City of Providence near the boundary line of said cities, wherever the Director of Public Works of the City of Providence and the Commissioner of Public Works of the City of Cranston shall agree that it is impractical to connect said houses to the City of Providence sewer system, and the City of Cranston at its own expense will dispose of such sewage in the same manner and by the same means as provided for the disposal of sewage in the City of Cranston.

THIRD: The right to connect to either sewer system, under the terms of this agreement, shall be determined by the Director of Public Works of the City of Providence and the Commissioner of Public Works of the City of Cranston, and to the end that the two Cities shall share the burdens and benefits of this agreement as equally as possible. However, all connections to either sewer system shall be in accordance with Ordinances, Resolutions, Rules and Regulations of both cities.

FOURTH: The right to discharge sewage into either sewer system shall be subject to and in conformity with all the laws of the State of Rhode Island and all General Laws, Ordinances, Resolutions, Rules and Regulations of the city receiving the sewage, now or hereafter in force during the continuance of this agreement, and neither city shall be under obligation to receive sewage into its system which is prohibited by any General Law, Ordinance, Resolution, Rule or Regulation, and no live steam, oil, gasoline or other explosive or other matter injurious to the sewers or sewer system of either city shall be allowed by either city to be conducted or discharged in the sewers or sewer system of the other.

This agreement may be terminated at any time by concurring action of the City Councils of the City of Providence

and the City of Cranston but it is understood and agreed that said termination shall not affect any sewer connections previously authorized and made under the terms of this agreement.

RESOLUTION OF THE CITY COUNCIL

Approved April 17, 1953

Resolved,

That in accordance with the provisions of Chapter 163 of the Ordinances approved October 21, 1948, entitled, "An Ordinance Establishing a Traffic Engineering Department, and Providing for the Appointment of a Traffic Engineer", the City Council of the City of Providence hereby approves regulations relative to the establishment of one-way streets, so that vehicles shall pass in one direction on the following streets as specified in said regulations, viz:

1. WASHINGTON STREET, to be a one-way street in a southwesterly direction from Exchange Place Mall to Empire Street.
2. MATHEWSON STREET (reversing the direction of the existing one-way flow) to be a one-way street in a northwesterly direction from Weybosset Street to Fountain Street.
3. UNION STREET (changing the direction of the flow from a northwesterly direction) to be a one-way street in a southeasterly direction from Fountain Street to Weybosset Street.
4. WEST APPROACH, UNION STATION, to be one-way in a southeasterly direction from Exchange Terrace to the Mall.
5. EAST APPROACH, UNION STATION, to be one-way in a southeasterly direction from Exchange Terrace to the Mall.
