

Dear Honorable Members:

I hereby disapprove and veto the ordinance in amendment of Chapter 21 of Article 1, by adding section 21-17, to be entitled: "City Treasurer authorized to contract with S.W.A.P. for the clearing of title and resale of tax reverted property", as amended.

The City Solicitor's Office which by charter is responsible for legal matters pertaining to the City should be authorized to contract for title work on tax reverted properties as opposed to the City Treasurer whose duties pertain to non-legal matters. Further, should the work performed under contract exceed limits as prescribed by the Providence City Charter then the Board of Contract and Supply shall be the contracting agency of the government.



CHAPTER

No. AN ORDINANCE IN AMENDMENT OF CHAPTER 21 OF ARTICLE 1, BY ADDING SECTION 21-17, TO BE ENTITLED: "CITY TREASURER AUTHORIZED TO CONTRACT WITH S.W.A.P. FOR THE CLEARING OF TITLE AND RESALE OF TAX REVERTED PROPERTY", AS AMENDED.

Approved

Be it ordained by the City of Providence:

SECTION 1. Chapter 21 of the Code of Ordinances of the City of Providence is hereby amended by adding Section 21-17, which shall read as follows:

"Section 21-17. City Treasurer authorized to contract with S.W.A.P. for the clearing of title and resale of Tax Reverted Property. The City Treasurer is authorized to contract with S.W.A.P. for legal services to clear title on tax reverted properties within the City of Providence under the following conditions:

(a) S.W.A.P. will arrange the clearance of title on these properties for a sum not to exceed One Thousand Dollars (\$1,000.00) per property.

(b) S.W.A.P. will seek qualified buyers for such property who shall purchase the property for at least the cost of title clearance and such buyers and purchase price shall be approved by the City Treasurer.

(c) Payment for title clearance shall be submitted on approved City of Providence forms and shall be paid from the Law Department Item 3 Account, but shall not exceed a total of Fifteen Thousand Dollars (\$15,000.00) in this current fiscal year."

SECTION 2. This Ordinance shall take effect upon its Passage.
