## VETO BY HIS HONOR THE MAYOR

Communication dated March 9, 1990, informing the Honorable City Council of his Disapproval and Veto of that Resolution Requesting the Providence Public Building Authority to exercise its rights of Eminent Domain to acquire certain parcels of land for a Public Park.

Dear Council President Easton:

I am vetoing a resolution passed by the City Council at its March 1st meeting. My understanding of the resolution was to compel the Providence Municipal Public Building Authority to acquire by means of eminent domain land currently owned by Miriam Hospital for use as a neighborhood park. While I wholeheartedly support the creation of a park in the Summit Avenue neighborhood, I feel that it is premature to compel the PBA to use its eminent domain powers.

Negotiations are currently underway that would allow Miriam to voluntarily offer land to

the city for a neighborhood park. This Resolution could jeopardize those negotiations and a lengthy court battle over eminent domain will only delay the construction of a park in that area.

It is my understanding that the Resolution in its present form fails to comply with RIGL section 45-50-10 which states that any act by the Public Building Authority must originate with the chief executive officer. I am, therefore, returning the Resolution to the City Council with my veto inasmuch as it was not introduced at my request.

As I have stated in the past, I am very much committed to a park in the Summit Avenue area, however, the use of eminent domain at this junction is premature and not in compliance with Rhode Island General Law.

The following Ordinance was in the City Council February 15, 1990, Read and Passed the First Time, Referred Back to Committee on Finance, and is Transmitted with Recommendation of Adoption, the Second Time:

An Ordinance in Amendment of Chapter 15 of the Code of Ordinances of the City of Providence, entitled: "Motor Vehicles and Traffic," as Amended.

*Be it ordained by the City of Providence:*

*Section I.* Chapter 15 of the Code of Ordinances of the City of Providence, entitled "Motor Vehicles and Traffic", as amended, is hereby further amended by adding thereto the following

**Article VIII. Reasonable Speeds.**

**Section 15-108. Reasonable and prudent speeds.**

No person shall drive a vehicle on a highway at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing in every event, speed shall be so controlled as may be necessary to avoid colliding with any person, vehicle, or other conveyance on or entering the highway in compliance with legal requirements and the duty of all persons to use due care.

**Section 15-109.** Conditions requiring reduced speed.

The driver of every vehicle shall, consistent with

the requirements of Section 15-108 drive at an appropriate reduced speed when approaching and crossing an intersection or railroad grade crossing, when approaching and going around a curve, when approaching a hill crest, when traveling upon any narrow or winding roadway and when special hazard exists with respect to pedestrians or other traffic or by reason of weather or highway conditions.

*Section 2.* This Ordinance shall take effect upon its passage.

**COMMITTEE ON PUBLIC WORKS**

Transmits the following with recommenda-  
tion the Same be Severally Adopted:

Resolution Authorizing His Honor the Mayor to enter into an Agreement authorizing North Main Associates, L.P. to erect and to maintain a Sign on Certain Land under Municipal Control.

*Resolved*, That His Honor the Mayor is authorized to enter into an agreement of easement granting permission to North Main Associates, (hereafter "NMA"), their successors and assigns to erect and maintain a free standing pylon sign within the line of Collyer Street. Said grant is predicated upon the following conditions:

a.) The sign and the area for its maintenance shall be a rectangular area not more than ten (10) feet by thirty (30) feet located adjacent to the easterly side of Collyer Street approximately one hundred ninety (190') feet northerly of the intersection of Collyer Street and Smithfield Avenue;

b.) Said grant shall continue for a term of twenty five (25) years provided; however, that NMA may retain said grant for five (5) successive year option periods. Each of said option periods shall be entered into only with the approval of the Providence City Council upon terms and conditions to be negotiated between the City Council and NMA before the commencement of each option period. The annual payment for said grant for the initial twenty-five (25) year period shall be 14.33 which shall be paid in advance on the first business day of each renewal year.

c.) That NMA enter into an agreement by which the City and members of the City Council are indemnified from any and all causes of action resulting from the erection and maintenance of the sign in a form satisfactory to the City Solicitor;

d.) That NMA provide proof of insurance in the amount not less than one hundred thousand (\$100,000.00) Dollars providing for coverage against personal injury and property damage. The City shall be listed as an additional insured on said policy;

e.) NMA shall proceed forthwith, to seek and to provide highway signage in the manner detailed before the City Council Committee on Public Works;

f.) That should the City of Providence at any time hereafter be entitled to assess abutting property owners for the private use and occupation of the public highways, this resolution shall in no manner affect the right of the City to charge and collect rent for the use of Collyer Street or any successor or assign in interest;

g.) The City shall retain a right of Reverter in the premises and should NMA fail to comply with or to abide by any of the above referenced conditions as well as any further restrictions imposed by the Mayor or the City Council or the City Solicitor, the premises shall automatically revert to the City of Providence, any Agreement shall be null and void and any easement or other fee extinguished without recourse by NMA;

Together with such other terms and conditions as may be imposed by His Honor the Mayor and the City Solicitor.

Resolution Granting Permission to the Providence Public Library at its Olneyville Square location to cause a Ramp to be erected along the Olneyville Square entrance to the Building.

The Providence Public Library (hereafter "P.P.L.") is hereby granted permission to erect a ramp along the Olneyville Square entrance to its Olneyville Square Branch. Said ramp shall extend not more than four (4) feet four (4) inches into the public right of way. Said permission shall continue for fifty (50) years unless earlier abrogated by agreement or as set out below. Said grant is conditioned upon:

a.) P.P.L. undertaking all construction in accordance with the plans submitted to the Director of the Department of Inspection and Standards;

b.) P.P.L. entering into an indemnification

agreement acceptable to the Office of the City Solicitor;

c.) P.P.L. providing insurance coverage against loss or injury in an amount of not less than One Hundred Thousand (\$100,000.00) Dollars with the City of Providence being named as an additional insured.

d.) That should the City of Providence at any time hereafter be entitled to assess abutting property owners for the private use and occupation of the public highways, this resolution shall in no manner affect the right of the City to charge and collect rent for the use of Collyer Street or any successor or assign in interest.

e.) The City shall retain a right of reverter in the premises and should P.P.L. fail to comply with or to abide by any of the above referenced conditions, the premises shall automatically revert to the full fee and control of the City of Providence any agreement hereunder shall be null and void, and any right or fee created hereunder shall be forever entinghished without recourse by P.P.L. and upon such other terms and conditions as may be imposed His Honor the Mayor and the City Solicitor.
