RESOLUTION APPROVING APPLICATION OF THE  
PROVISIONS OF SECTION 23 OF THE UNITED  
STATES HOUSING ACT OF 1937, AS AMENDED,  
TO LOCALITY

WHEREAS, Under the provisions of Section 23 of the United States Housing Act of 1937, as amended, the United States of America, acting through the Secretary of Housing and Urban Development, is authorized to provide financial assistance to local public housing agencies in providing low-rent housing by leasing dwelling units in privately-owned structures; and

WHEREAS, Said Section 23 provides that the provisions thereof shall not apply to any locality unless the governing body of the locality has by resolution approved the application of such provisions to such locality.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Providence, Rhode Island, as follows:

That the application of the provisions of Section 23 of the United States Housing Act of 1937, as amended, to the City of Providence, Providence County, State of Rhode Island, is approved.

I am writing with reference to Resolution No. 378, approved June 19th, 1974 by the Honorable City Council.

This Resolution pertains to approving "Application of the Provisions of Section 23 of the United States Housing Act of 1937, As Amended, to Locality", and incidentally, the matter that I discussed with you on Wednesday, September 25th, 1974 on an informal basis.


