


Dear Honorable Members:

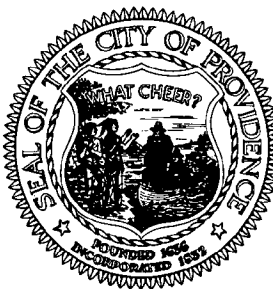



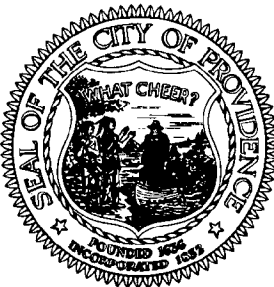
