

Dear Councilman Flynn:

Please be advised that this Department has reviewed the request of Makam's Deli and Fine Foods Restaurant, at 31 Aborn Street, Providence, to erect an awning from the front of the restaurant to the curb line and to allow the door to swing outward three feet on to the sidewalk.

It is my recommendation at this time that this petition be denied, pending plans showing the exact size and location of the awning and showing provisions to prevent people from being struck by the door when opening.

At the present time it is unclear as to what size awning is to be erected. If the awning is too low, it would constantly be hit by trucks trying to make it down this very narrow street. Both the Zoning Ordinance and the R.I. State Building Code requires at least a two foot setback from the curb line since many large trucks are built so that the body overhangs the wheels.

Unless this awning was set back it would be very easy for a truck to knock down such an awning without even jumping the curb.

With regards to the request to swing a door onto the sidewalk, this Department would have no objection provided there would be some obstruction (such as a planter) to keep people away from the face of building, thereby preventing the door to be opened into their face.
