RE: PETITION REQUESTING PERMISSION TO  
ERECT SNACK BAR

Pursuant to your request for an opinion on the petition pending before your Committee with regard to the construction of a portable snack bar on the Dexter Training Grounds, I am herewith transmitting said opinion.

By virtue of Section 18-12 of the City Code of Ordinances, all sales of goods are prohibited on City-owned or controlled property without prior approval of the Superintendent of Parks or the Board of Park Commissioners.

Since said Board is an agent of the City Council, then the City Council can, if it deems it necessary, direct said Board to issue said approval in accordance with Section 18-12 of the City Code.

In light of the foregoing, it is this Department's opinion that said Committee can grant said petition.
