COUNCILMAN JACKSON Requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

Thank you Council President. I rise on a point of Personal Privilege and also I would like to recognize tonight we have numerous members of the Clerical Union of the School Department. I know they have come down out of concern in regards to their contract, I just want to recognize that fact and thank them for the hard work they do in the School Department and also to go over the dates and the time sequence in regards to their contract because I know that is of great concern. The City Council itself received the contract on October 5th of this year. It came off the Council Docket and was referred to the Finance Committee in the first meeting of that October, the Finance Committee meeting heard it on October 24th of this year and then scheduled a Public Hearing. By law we have to advertise that for ten consecutive days which meant that the earliest we could have had the Public Hearing was on November 7, 2000, it was already a scheduled Ordinance Committee Public Hearing on November 7th so therefore, we had to schedule it on November 8, 2000. Obviously at that time, people were not aware that November 9th was going to be the day that the City celebrated the Veteran's Day observance so the docket had to be closed on November 8th at four o'clock. The Finance Committee meeting had the Public Hearing on November 8th at 6:00 o'clock on the rise of the Public Hearing we went into the committee room and the Finance Committee passed the contract to be referred back to the full Council. Obviously that was approximately probably was two and a half hours passed the docket deadline. So it could not be on tonight's docket,

it must go on the first Thursday of December's docket to be passed at this time by this Honorable Body so that's the sequence, I just wanted to explain the sequence of events that happened in regards to that contract, there are no issues that the Finance Committee brought up in regards to that contract, there were no issues brought up during the Public Hearing during the contract and it's just again unfortunate that there happens to be five Thursdays in the month of November so it can't be heard, the Council only meets on the first and third Thursdays of the month. Thank you for your time.

COUNCILWOMAN YOUNG Requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

Thank you Mr. President. I would be not me if I didn't bring up this article I read in the Providence Journal dated Wednesday, November 15, 2000, and this headline says "The Union to take the vote on the Chief" and in case your not sure what human we're talking what chief we're talking about. We're talking about the Police Union and they're getting ready to take a vote of no confidence on Chief Urbano Prignano Jr., who is the Chief of Police because they're concerned about allegations that our Chief of Police may, and I say allegations because it hasn't been proven yet may have been involved in assisting individuals with giving them answers to exams, doing other things with contracts and not leveling the playing field, and making it a fair playing field and I bring that to mention to you because it

is important that several months ago me and some of my colleagues had concern about the same chief and low and behold numerous individuals came to his rescue. One group being the Providence Police Union, Mike Marcoccio said "this is a good chief, he's doing everything the right way." What a difference a few months makes and what a difference when I think the word is called hypocrite be it the lesser affects his men and his women and all it is affecting is their pocket book, they're not going to get the money or the stripes on their shoulder, but what's affecting my community is much more than that. This whole City was being affected by the crisis that exist then and exists today in the Providence Police Department. Crisis of missing drugs, of gold jewelry and other items missing. Two hundred cars missing and not accounted for, a Police Woman enraged assaulting a citizen of this City. To name a few,

the killing of Cornel Young, Jr., just a few things, I'm not naming everything that has happened, so all of sudden you see because of their personal interest only when it affects them in their pocketbook are they going to say and these are allegations mind you. What I just present to you are facts, it happened, it exists. I just think that when you look at these, this document right here what a bunch of hypocrites they are. This is the leadership of the union. Last year they wanted him out this year they wanted, earlier they wanted him in, today they want him out. They're totally inconsistent but I'm consistent about what I believe in and what I think is right for the City and to see the article here because of allegations not facts, to me is hypocritical. Thank you very much Mr. President.
