

RESOLUTION OF THE CITY COUNCIL

No. 414

Approved August 8, 1996

WHEREAS, The Providence City Council does hereby create a Study Commission of the City Council for the purpose to avoid the closing of that Nursing Home, known as the Bannister Nursing Care Center by the State of Rhode Island, and

WHEREAS, Such a closing of the above mentioned facility would cause the unemployment of some hundred or so people, who are Providence residents, and

WHEREAS, Most of the people working there are people of the minority community, some who have been employed by the nursing center for years, and

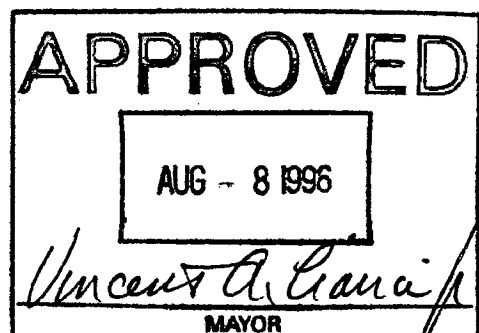
WHEREAS, The patients there would have to relocate to other nursing homes where there are waiting lists a mile long and almost impossible for them to be admitted to most nursing homes in the Providence Area, and

WHEREAS, The City Council believes that such a commission should be created due to the fact that the City has spent thousands of dollars on repairs to the roof and other parts of the building, and

WHEREAS, Under Rule 27 (b) of the Rules of the City Council, the commission shall consist of Nine (9) Members, Three (3) of whom shall be City Council Members appointed by the City Council President, One (1) of whom shall be the State Senator of the District, One (1) of whom shall be the State Representative of the District, One (1) of whom shall be the City Council Internal Auditor, One (1) of whom shall be a Health Care Official, One (1) of whom shall be of the Department of Planning and Development and One (1) of whom shall be of the State Department of Human Services,

NOW, THEREFORE, BE IT RESOLVED, that the Study Commission on the Bannister Nursing Care Center shall be created and shall respond to the City Council no later than November 1, 1996.

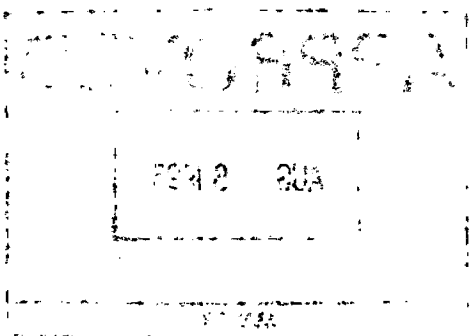




