A PETITION HAS BEEN SIGNED BY THE RESIDENTS & NEIGHBORS OF NETOP DRIVE TO CHANGE THE NAME LISTED AS NETOP ROW TO ANOTHER SUITABLE NAME.

OVER THE PAST TWO YEARS, NUMEROUS DELIVERIES OF MAIL COME TO NETOP DRIVE, WHEN THEY SHOULD GO TO NETOW ROW VICEVERSA. NUMEROUS COMPLAINTS HAVE BEEN MADE TO THE U.S. POSTAL SERVICE WHO HAVE STATED THEY ADHERENTLY OPPOSED NAMING THE NEW STREET NETOP ROW BECAUSE HAVING THE SAME ZIP CODE 02907 WOULD HAMPER THE PROPER DELIVERY OF MAIL.

INCIDENTS - 17 NETOP DRIVE - AS FOLLOWS:

1. NUMEROUS LATE DELIVERY OR NON-DELIVERY OF MAIL.
2. HARRASSING PHONE CALLS - LOOKING FOR RESIDENTS OF NETOW ROW.
3. CONSTABLE WITH SUMMONS - AT WRONG HOUSE SHOULD BE AT NETOP ROW.
4. A PROVIDENCE POLICE DISPATCHER WHO LIVES DIRECTLY ACROSS 17 NETOP DRIVE HEARS A CALL AT WORK THAT THERE IS A BREAK-IN AT THIS RESIDENCE - HE INTERCEDES THAT IT SHOULD BE AT NETOP ROW.
5. ON SEVERAL OCCASIONS LATE EVENING, POLICE SEARCHING THE GROUNDS - WRONG HOUSE - SHOULD BE AT NETOP ROW.
6. AUGUST 11, 1992 6:00 A.M. - NEIGHBORS AWAKENED BY BANGING ON FRONT DOOR OF RESIDENT, WHO HAD ALREADY LEFT FOR WORK, OBSERVED WERE 4 MEN WITH UNMARKED CARS WITH IMMIGRATION DEPT. ON BACK OF JACKETS.

AUGUST 15, RESIDENT CALLS SIP (SPECIAL INVESTIGATION POLICE BUREAU) TO REPORT THIS INCIDENT AND TO OBTAIN PHONE NUMBER OF IMMIGRATION. SPOKE WITH JAMES HEATHMAN WHO CONDUCTED THE RAID WHO DIDN'T KNOW THERE WAS A NETOP ROW AND APOLOGIZED FOR BEING AT THE WRONG ADDRESS.

7. LETTER POSTMARKED 9-19-92 BROCKTON WAS RECEIVED OCT. 13TH, BECAUSE IT HAD GONE TO NETOP ROW & HAD TO BE RE-ROUTED TO NETOP DRIVE.

INCIDENTS - 20 NETOP DRIVE - AS FOLLOWS:

1. PROBLEMS WITH MAIL DELIVERY.
2. POLICE KNOCKING ON FRONT DOOR AFTER MIDNIGHT - SHOULD BE AT NETOP ROW.
3. RESIDENTS FROM NETOP ROW - IN PERSON LOOKING FOR THEIR MAIL.
4. NARRAGANSETT ELECTRIC & PROVIDENCE GAS READY TO SHUT OFF SERVICE WHEN IN FACT THEY SHOULD BE AT NETOP ROW.
5. HARRASSING PHONE CALLS - LOOKING FOR RESIDENTS OF NETOP ROW.

INCIDENT - 50 NETOP DRIVE

RESIDENT HAS STATED LAST YEAR THE SCHOOL BUS WAS DROPPING HER SON OFF AT NETOP ROW, HER SON WAS IN KINDERGARTEN AND TOLD THE BUS DRIVER I DON'T LIVE HERE.

ANOTHER RECENT EXAMPLE OF MISDIRECTED MAIL OCCURRED DURING THE SEPT. 15TH PRIMARIES, THE NETOP ROW VOTERS WERE INCLUDED WITH THE NETOP DRIVE VOTERS OF REPRESENTATIVE DISTRICT 8 MAIL LIST,

EVERY RESIDENT OF NETOP DRIVE IS A HOME OWNER AND PROPERTY TAX PAYER AND THE PRIVATE RIGHTS OF THESE INDIVIDUALS ARE BEING VIOLATED.
