ORDINANCE SECOND READING

The following Ordinance was in City
Council October 19, 2000, Read and Passed
the First Time and is returned for Passage
the Second Time:

An Ordinance Amending the City of
Providence Zoning Ordinance Chapter 1994-24,
No. 365, Approved June 27, 1994, As Amended
(Special Flood Hazard Area).

Be it ordained by the City of Providence:

Section 1. The Providence Zoning Ordinance Chapter 1994-24 No. 365, approved June 27, 1994, as amended, shall be further amended as follows:

Section 423 — Special Flood Hazard Area shall be deleted in its entirety and replaced with a new Section 423, which shall read as follows:

Section 423 — Special Flood Hazard Areas: Any construction or development,

wholly or partially, within a Special Flood Hazard Area Zones A, AE, AH, AO, A99, V and VE, X, and D as identified on the Flood Insurance Rate Maps (FIRM) Community Panel Numbers 445406 0001 through 445406 0007 inclusive, dated June 6, 2000 (as amended), prepared by the Federal Emergency Management Agency shall conform to the requirements of this Section. Said FIRM shall guide the Director in determining floor elevations and other flood protective and flood preventive requirements involved in the administration and enforcement of this ordinance and the Rhode Island Building Code.

423.1 — Special Flood Hazard Areas — Prohibitions: The following shall apply in special flood hazard areas:

A) No manufactured home, as defined by the Rhode Island Building Code shall be located in any floodway or coastal high hazard area.

B) All new construction shall be located landward of the reach of mean high tide in a Velocity Zone.

C) Man-made alteration of sand dunes within a Velocity Zone (V-VE) shall be prohibited.

D) Any encroachment in the regulatory floodway as identified on the FIRM is prohibited. This includes fill, new construction, substantial improvements to existing structures and other development. However, encroachment in the regulatory floodway may be permitted if the applicant shall provide a certification by a registered professional engineer demonstrating that such encroachment shall not result in any increase in flood elevations during a base flood (one hundred year flood).

Section 2. This Ordinance shall take effect upon passage.

PERSONAL EXPRESSION

COUNCILWOMAN DiRUZZO requests the privilege of the floor to speak on a point of personal expression and states:

"I rise to memorialize the Housing Court Chief Justice, Irving Brodsky, and I ask that this meeting be adjourned in his memory. Last week on Friday, we lost, I lost, a very good friend, Judge Brodsky. To those of you who did not know him very well, I think it is important that you know the real person that Irving was. He was a very sensitive and loving person. Although many times he didn't come across as being that, most of the time he came across as being a harsh person, let me assure you to those of us who knew him, and to those of us who

were involved in his life, that we felt his loyalty, his dedication, his sensitivity, and he shared his love for us every day. I have lost my teacher. When I worked for Irving in the late 1960s, he taught me all that I know about the law. He worked then as special state prosecutor, and I, many times, spent time with him in the courtroom. So all that I know about the law and the presentation of the law arguments that you see me conduct myself with here in this forum, were taught to me by Judge Brodsky. I have lost a good friend and I will miss him dearly. To adjourn this meeting in his memory, I would like to read into the record a resolution, a proclamation, from Mayor Cianci's office:

Whereas, Irving Brodsky, Chief Judge of the Providence Housing Court for nearly eight years, having served the City of Providence as its associate/Chief Judge, as well as City Solicitor, and who for fourteen years served the State of Rhode Island as an Assistant Attorney General with distinction and honor, has left all who mourn his passing with a legacy of exemplary service to the state and the city he loved, and

Whereas, A loving and devoted husband of Naomi Richmond Brodsky for 61 years. Cherished father of David and Richard Brodsky, and loving grandfather to Peter, Jane, Ben, Isabell and Nell. Throughout his lifetime he demonstrated insight, integrity, intelligence and impeccable knowledge of law, having graduated from Classical High School before earning his undergraduate degree from Brown University and his law degree from Harvard Law School, as his sons did, and

Whereas, Having been actively engaged in the practice of law since 1938, Irving Brodsky also gave fully to his city and community through his valued and valuable involvement, and organizations including the Jewish Family and Children's Service of Rhode Island, and Temple Beth Israel, and to his many friends, colleagues and admirers who remain inspired by his lifelong sincerity and loyalty, goodness and compassion, and

Whereas, The people of the City of Providence salute and honor the Providence Housing Court's Chief Judge, Irving Brodsky, for the

ways in which he has so positively affected and changed the life of all who live in the city. The impact of his brilliant man and a brilliant attorney. They serve as evident at every corner as we extend our heartfelt sympathies to his loving family, and I say tonight that he will be sorely missed by myself and my family. Thank you."

COUNCILWOMAN NOLAN requests the privilege of the floor to speak on a point of personal expression and states:

"I will miss my afternoons in Housing Court with Judge Brodsky when we were fighting one particular landlord who . . . they owned 11 houses on Adelaide Avenue that were in terrible, decrepit shape that are now being foreclosed by and the attorney's constantly would ask for a continuance so all those hours we spent in that courtroom, it was almost as though they were getting away with something and they were, but not because of Judge Brodsky, he was just as frustrated as I was and as the city prosecutor was. Those days are gone. HUD has reached its limit and is going to foreclose on those 11 properties, but I will never forget how Judge Brodsky tried to get the attorneys involved, all of the attorneys, and believe me there were lots of them, to do the right thing about these properties. I will miss him very much."
