

RESOLUTION OF THE CITY COUNCIL

No. 86

Approved February 12, 1993

WHEREAS, Prostitution has been a persistent problem in many of the neighborhoods in the City of Providence, and

WHEREAS, Many of these same neighborhoods are also plagued by the problem of littered vacant lots, and

WHEREAS, Both of these problems are most often caused by people from outside of the neighborhoods in which litter is dumped and in which prostitution occurs, and

WHEREAS, Assigning those convicted of solicitation, prostitution, or littering on vacant land to community service work would help to rehabilitate the offenders and improve the neighborhoods which suffer by reason of these illegal activities,

NOW, THEREFORE, BE IT RESOLVED, That the Honorable Justices of the District Courts of the State of Rhode Island and the Honorable Judges of the Municipal Court of the City of Providence are respectfully requested in those instances they deem appropriate to consider imposing community service sentences so that prostitution and/or littering offenders are required to clean and/or maintain vacant lots in the areas in which the activities occurred.


