AN ORDINANCE IN AMENDMENT OF CHAPTER 544 OF 1951 BY CHANGING FROM AN R-2 TWO-FAMILY ZONE TO A C-1 LIMITED COMMERCIAL ZONE, LOT 384, AS SET OUT AND DELINEATED ON CITY ASSESSOR'S PLAT 78, SAID LOT BEING SITUATED ALONG 408 VEAZIE STREET.

Be it ordained by the City of Providence:

SECTION 1. The Zoning Map, accompanying and made part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, entitled: "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations," as heretofore amended, is hereby further amended by changing from an R-2 Two Family Zone to a C-1 Limited Commercial Zone, Lot 384, as set out and delineated on City Assessor's Plat 78, said lot being situated along 408 Veazie Street, bounded and described as follows:

Beginning at a point on the northeasterly line of Veazie Street, said point being the southeasterly corner of herein described parcel; thence following an irregular line in northeasterly direction to the northwesterly corner of herein described parcel; thence generally northeasterly to the northeasterly corner of herein described parcel, said point being on the southerly line of Houghton Street (so-called); thence southeasterly along the southerly line of Houghton Street (so-called) to the northeasterly line of Veazie Street; thence in a generally southwesterly direction along the northeasterly line of Veazie Street to the southwesterly corner of herein described parcel, said point being point and place of beginning.

SECTION 2. This Ordinance shall take effect upon its Passage.

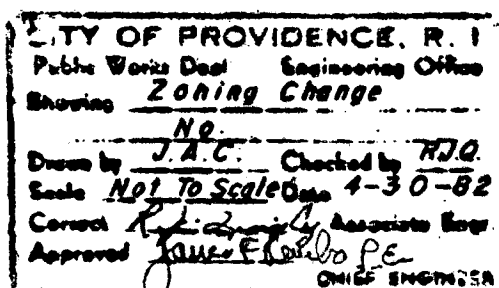

Gentlemen:

The City Plan Commission, at its June 9, 1982 rescheduled monthly meeting, reviewed and evaluated the subject referral which contained a request by Thomas Ricci for the rezoning of the subject lot from R-2 Two-family Zone to C-1 Limited Commercial Zone.

The subject lot contains 38,960 sq. ft. of land and is located at the westerly corner of Veazie and Houghton Streets with a 185 ft. frontage on Veazie Street and a 200 foot frontage on Houghton Street.

A field inspection revealed that the subject lot is vacant and unimproved. It is located between the M-1 Industrial Zone (front and rear) and between a river and Houghton Street at its side lot lines.

The Commission

Voted: - To recommend to the Committee on Ordinances that this petition be denied, due to the fact that an existing R-2 district, lying to the east of the subject site and along Fairwood Drive, would be isolated and surrounded by M-1 Uses.
