WHEREAS, They raised their nine children in that home and helped raise their many grandchildren and great-grandchildren there, as well; and

WHEREAS, In their many decades in South Providence, the Lawrences have become pillars of their community, who friends and neighbors have continually turned to for wisdom and support; and

WHEREAS, Mr. and Mrs. Lawrence have instilled the values of kindness, forgiveness, and respect in their family, and have taught the importance of those values to all who have sought their advice; and

WHEREAS, In 1952, the Church of God in Jesus Christ held its first ever prayer meeting in the Lawrences' living room on Rhodes Street; and

WHEREAS, The Lawrences have set an incredible example for all Rhode Islanders of how to live a life focused on faith, family, and community; and

WHEREAS, Renaming and rededicating the Alphonso Street Park in Arthur and Ruby Lawrence's honor is a fitting tribute that will ensure their many contributions to life in Providence will never be forgotten.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby honor and congratulate Arthur and Ruby Lawrence on the occasion of their 75th wedding anniversary.



BE IT FURTHER RESOLVED, That the Alphonso Street Park, located at 10 Alphonso Street, shall be known as the "Arthur and Ruby Lawrence Neighborhood Park."


