Gentlemen:

Our attention has been called to the proposed Bill recently passed by the House of Representatives, which while ostensibly raising the standards of milk to those of the City of Providence, yet by changing the requirements for total solids, actually lowers the quality of the milk sold in the state.

Under State Law, local communities may improve the sanitary quality of milk but cannot improve the food value of milk. Thus, if the Bill at present in the Senate is passed, the food value of milk will be reduced.

While it is true that it is impossible to have milk with a minimum 12% total solids, if the butterfat is only 3.25 percent, the results of the law at present fixes the minimum butter fat at 3.5 per cent.

If it is the intent to remove the discrepancies in the present law, it would be better to maintain the present food value standards by raising the minimum butter fat content to 3.5 per cent for all milk, Grade A and B, rather than lower the Grade B standards.

We respectfully request that your Honorable Body express itself against any change lowering the food value of Grade B milk.

SUBJECT: PARKING RESTRICTION - THACKERAY STREET

Dear Commissioner Dunn:

At the request of Council Resolution #75, dated February 5, 1954, the traffic engineer has investigated the establishment of TIME PARKING on Thackeray Street. Since Thackeray Street is 30 feet wide and can support parking on one side and safely permit two lanes of moving traffic, ONE HOUR PARKING from 8AM to 6PM is hereby established on the north side of Thackeray Street from Elmwood Avenue to Melrose Street.

This regulation rescinds the NO PARKING ANY TIME formerly established in this above area.

SUBJECT: PARKING RESTRICTION - REGENT AVENUE

Dear Commissioner Dunn:

At the request of Council Resolution No. 779, dated December 18, 1953, the traffic engineer has studied the feasibility of restricting parking to one side of Regent Avenue from River Avenue to the entrance of the U.S. Veterans Hospital. From investigations made in the field, it was observed that this problem of solid parking persists on both sides of Regent Avenue from Robin Street to the Veterans Hospital and is most hazardous during the heavier traffic flows throughout the day, therefore NO PARKING from 7 A.M. to 6 P.M. is hereby established on Regent Avenue from Robin Street to the Veterans Hospital.
