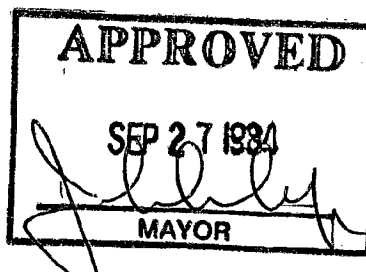

to grant permission to construct a handicapped access ramp on the Hewes Street side of the building occupied by Rhode Island Group Health Association (RIGHA), located at 530 North Main Street. This ramp, along with a curb cut, would allow better wheelchair access for RIGHA members, and would facilitate access for ambulances delivering and picking up patients. As the attached plans show, the ramp would occupy a portion of the public sidewalk; however, the remaining portion of the sidewalk meets access requirements.

Dear Sirs:

Please be advised that this Department has reviewed the request by the Rhode Island Group Health Association to construct a handicapped access ramp on Hewes Street.

In order to meet code requirements, the proposed conditions shown on the plans must be slightly altered. The width of the ramp excluding the curbing must be a minimum of 4', not 3'7", and the landing must be extended 2' past the door opening, making the width of the landing 7' instead of 5'.

This Department would recommend approval of the petition with the above corrections. The corrections have been noted on the plans for your convenience.

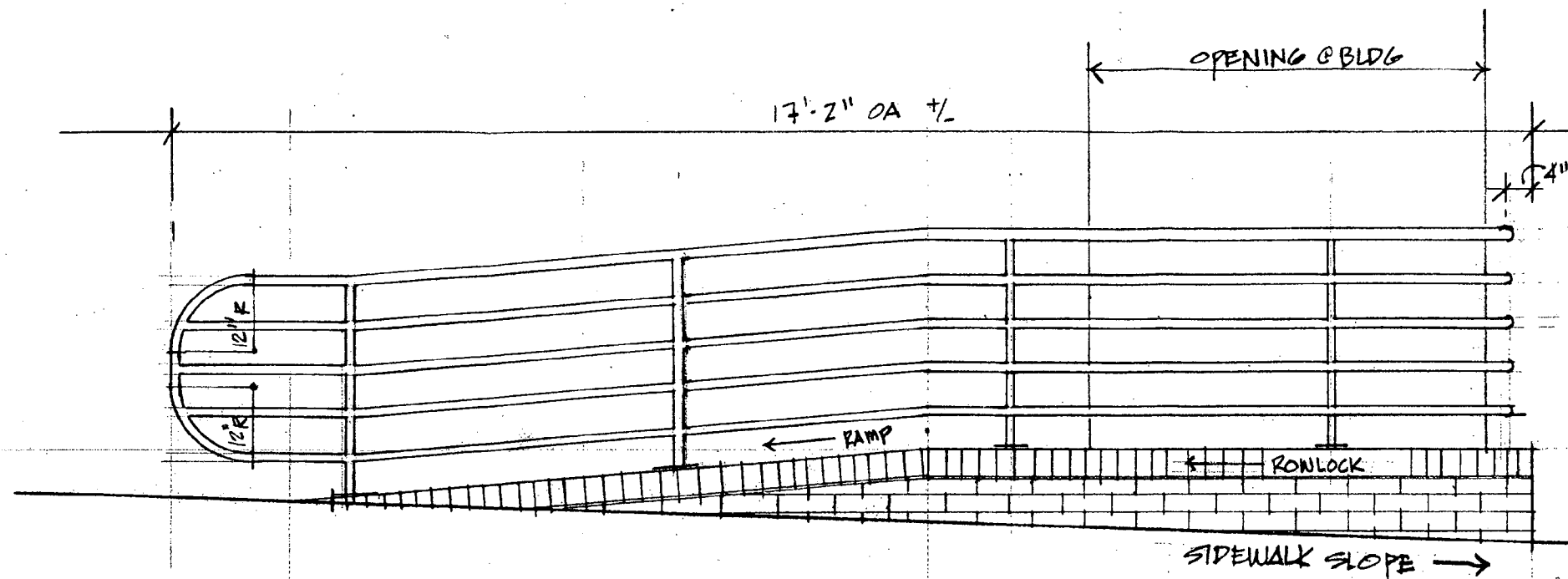

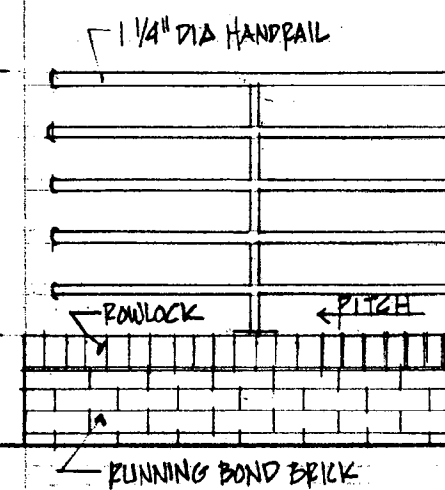

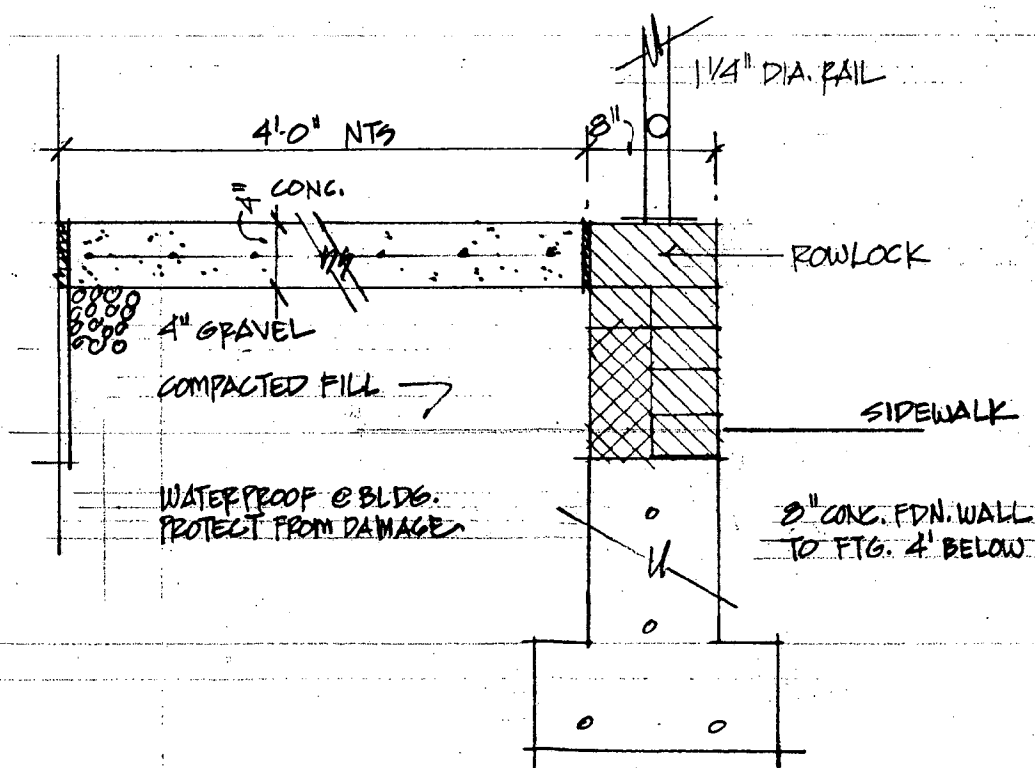
ELEVATION A

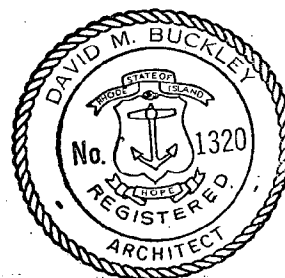


ELEVATION B
