Dear Honorable Members:

I hereby disapprove and veto an Ordinance entitled "Employees to be Residents; Exceptions," as amended. I take this action for the following reasons:

1. The ordinance is unnecessary in that Section 1210 of the Providence Home Rule Charter of 1980 provides adequate provisions to ensure that City officers and employees are Providence Residents;

2. The ordinance is an improper usurpation of Executive Power by the Legislative branch of government in that it unduly infringes upon the Executive's hiring prerogatives;

3. The ordinance is likely to cause unacceptable delay in the employment of new City officers and employees in that it requires legislative exemption for the hiring of non-residents.

The intent of this legislation, to ensure strict compliance with the provisions of Section 1210 of the Providence Home Rule Charter, is an admirable one, and one with which I concur. It is my intention to require all persons entering into City service to be Providence residents or become Providence residents within the statutorily-mandated time period.

I believe, however, that this Ordinance attempts to accomplish that result in a manner that conflicts with the proper balance of power among the branches of government.
