


The Providence Neighborhood Community Centers, of which there are 10, have been receiving a grant award, in the amount of \$30,000 per center each year for the past several years, from the City budget.

On Friday, January 14, 2005 many community centers received a payment from the City of Providence in the amount of \$10,000 as the final disbursement for their total allocation of \$25,000 for Fiscal Year 2005.


Most community centers had individually received \$30,000 in previous Fiscal Years dating back several years. This year, however, there was a reduction in the amount of \$5,000 to this allocation, and no notification had been given to Center Directors regarding this decrease.

I wanted to write and inform you that I will take all necessary actions to make the Community Center allocations whole.
