It is enacted by the General Assembly as follows:

1 SECTION 1. Section 11-8-2 of the General Laws in Chapter
2 11-8 entitled "Burglary and breaking and entering" is hereby
3 amended to read as follows:

4 11-8-2. Unlawful breaking and entering of dwelling house.

5 -- Every person who shall break and enter at any time of the day
6 or night any dwelling house or apartment, whether the same is
7 occupied or not, or any outbuilding or garage attached to or ad-
8 joining any dwelling house, without the consent of the owner or
9 tenant of such dwelling house, apartment, building, or garage,
10 shall be imprisoned not less than one (1) year nor more than five
11 (5) years or and fined more than five hundred dollars (\$500). or
12 ~~shall-suffer-both-such-fine-and-imprisonment-~~

13 Any person found guilty of a crime under this section shall
14 not be afforded the provisions of suspension or deferment of sen-
15 tence, or of probation.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

1 This act would provide a mandatory prison sentence of not
