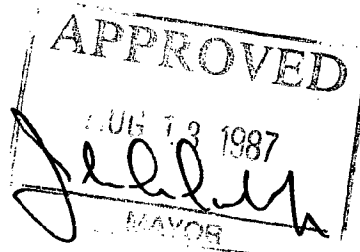



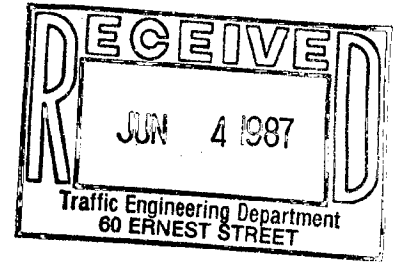

WHEREAS, the City of Providence is eligible to receive Community Development Block Grant Entitlement Funds for fiscal year 1987-1988 under Section 106(a) or (h) of Title I of the Housing and Community Development Technical Amendments Act of 1984 (Public Law 98-479); and

WHEREAS, the Statement of Objectives and Funding shall be filed with the Boston Area Office of the Department of Housing and Urban Development as soon as possible.

NOW, THEREFORE, The City Council of the City of Providence, County of Providence, State of Rhode Island, hereby authorizes the City of Providence, through its official representative, the Mayor, to file a STATEMENT OF OBJECTIVES AND FUNDING with the Boston Area Office of the Department of Housing and Urban Development for the purpose of obtaining Community Development Block Grant Funds.

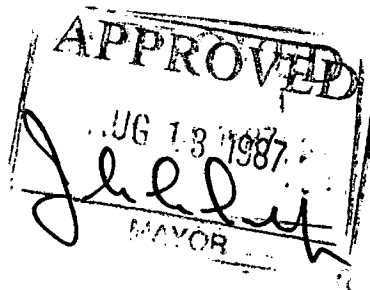
