RESOLUTION OF THE CITY COUNCIL

No. 74

Approved January 24, 1995

WHEREAS, Resolution No. 281 of the City Council created a Committee on Education on May 10, 1991; and

WHEREAS, the charge of said Committee was "an advisory one for the purpose of promoting communication on school issues with the goal of promoting quality education in the City of Providence"; and

WHEREAS, said Committee as established is inconsistent with the Rules of City Council adopted on January 2, 1995; and

WHEREAS, Rule 27 of said Rules of the City Council provides for the creation of Study Commissions; and

WHEREAS, the City Council believes that the study of school issues is important to the future deliberations of the City Council;

NOW, THEREFORE, BE IT RESOLVED That pursuant to, Rule 27 of the Rules of the City Council a *Study Commission on Education* is hereby created;

BE IT FURTHER RESOLVED That the purpose and charge of said Study Commission shall be to advise the City Council on school issues with the goal of promoting quality education in the City of Providence;

BE IT FURTHER RESOLVED That said Study Commission shall consist of eleven (11) members appointed by the President of the City Council including five (5) members of the City Council, one (1) representative of the Mayor, one (1) representative of the Superintendent of Schools, one (1) member of the American Federation of Teachers, Local #958, and three (3) representatives of the community-wide Parent Teachers Association;

BE IT FURTHER RESOLVED That the chairperson and vice-chairperson of said Study Commission shall be appointed by the President of the City Council;

BE IT FURTHER RESOLVED That any and all reports from said study commission shall be submitted to the City Council by filing said reports with the City Clerk;

BE IT FURTHER RESOLVED That the term of said study commission shall expire on January 1, 1996.
