Be it ordained by the City of Providence:

SECTION 1. The City Council hereby authorizes the Committee on City Property to Allocate Office Space within any City owned or leased buildings for any official purpose; said allocation of office space shall be made upon written request, filed with the City Clerk, noting the proposed use and the area required.

The City Clerk shall upon the receipt of such request, inform the Chairman of the Committee on City Property, of such notice.
