Whereas, The Authority may now duly transact its business of acquiring and constructing public facilities, acquiring public equipment; maintaining, renovating, repairing and operating the same; and issuing its revenue bonds and/or notes to finance the public facilities and public equipment; and

Whereas, The Authority may develop its projects only upon the request of the Mayor and the City Council; and

Whereas, Such request must take the form of a proposal by the Mayor approved by the City Council; and

Whereas, The Mayor has submitted the proposal attached hereto as Exhibit "A" for the City Council's approval.

Now, therefore, be it Resolved,

1. That the City Council hereby approves the Proposal of the Mayor dated September 5, 1996 (the "Proposal") which, among other things, requests the Authority to use its best efforts to develop the Project which shall include, the acquisition, construction, renovation, rehabilitation, improvements, furnishing and equipping of existing buildings including, but not limited to, the John Street School, the St. Anthony School, the Bridgham Middle School and real estate and improvements located at 234 Daboll Street (Assessor's Plat 43, Lot 570), 90 Mawney Street (Assessor's Plat 43, Lot 568), 81 Mawney Street (Assessor's Plat 49, Lot 469) and 83 Burnett Street (Assessor's Plat 49, Lot 479) in Providence for use as public schools, a parent-child center, and a day care center and any other acts necessary or incidental thereto, and to issue Bonds and/or Notes in an amount not to exceed Twenty-Two Million Dollars (\$22,000,000.00) to provide funding for the Project.

2. That the President of the City Council be, and he hereby is, authorized to execute the Proposal and to deliver it to the Authority.

3. That the City Council hereby authorizes the Mayor to negotiate and lease the Project from the Authority.

4. That the Mayor be, and he hereby is, authorized to take any and all action and to execute, file and deliver any and all agreements, notes, deeds, leases and other documents as he,

in his sole discretion, may deem necessary or desirable to implement the transaction contemplated by the Proposal.

5. That the Authority shall submit all estimates, bids, etc. regarding such construction, renovation, rehabilitation, improvement, furnishing, and equipping of the Project to the Committee on Finance of the City Council as such estimates become available.

6. The City's Director of Finance is authorized to execute and deliver the continuing disclosure certificates in connection with the bonds and or notes issued by the Authority, in such form as shall be deemed advisable by the City's Director of Finance. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of each continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Resolution or the bonds or notes, failure of the City to comply with any continuing disclosure certificate shall not be considered an event of default; however, any bondholder or noteholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Resolution and under any continuing disclosure certificate.

7. This Resolution is an affirmative action of the City Council towards the issuance of the Authority's Bonds and/or Notes in accordance with the purposes of the laws of the State. This Resolution constitutes the City's declaration of official intent, pursuant to Treasury Regulation Section 1.150-2, to reimburse its General Fund in an amount not to exceed Twenty-two Million Dollars (\$22,000,000.00) for certain capital expenditures for the Project paid on or after the date which is sixty (60) days prior to the Authority's Bonds and/or Notes. Amounts to be reimbursed shall be reimbursed not later than eighteen months after (a) the date on which the expenditure is paid or (b) the date the Project is placed in service or abandoned, but in no event

more than three (3) years after the date the expenditure is paid.

8. This Resolution shall take effect on passage.

Whereas, The City of Providence, Rhode Island (the "City") has received a written communication from Leviton Manufacturing Co., Inc., of Little Neck, New York ("Leviton") with respect to property owned by Leviton within the City and located at 234 Daboll Street (Assessor's Plat 43, Lot 570), 90 Mawney Street (Assessor's Plat 43, Lot 568), 81 Mawney Street (Assessor's Plat 49, Lot 469) and 83 Burnett Street (Assessor's Plat 49, Lot 479) (hereinafter, all of such real estate and the improvements located thereon are referred to as "the Cable Electric Property"); and

Whereas, The terms of such communication provide, amongst other things, that Leviton will sell the Cable Electric Property to the City for the sum of One (\$1.00) Dollar provided that the City agrees to assume certain carrying costs and provide Leviton with certain indemnification agreements with respect to the Cable Electric Property, all as provided in a certain draft purchase and sale agreement by and amongst Leviton and the City, a true copy of which is attached hereto as Exhibit A (hereinafter, the "Agreement"); and

Whereas, Embodied in the Agreement is a request of Leviton and the City represent that it intends to use the Cable Electric Property for public school purposes; and

Whereas, The City intends to acquire, construct,

renovate, rehabilitate, furnish, equip the Cable Electric Property for use as two public elementary schools; and

Now, therefore, be it Resolved,

1. That the City Council hereby approves of the terms and conditions of the Agreement attached hereto as Exhibit A.

2. That the Mayor be and he hereby is authorized to execute the Agreement for and on behalf of the City and deliver the same to Leviton and to take any and all actions and execute any and all documents necessary or desirable to implement the transaction contemplated by the Agreement.

3. This Resolution shall take effect upon passage.

PERSONAL EXPRESSION

COUNCILMAN ROLLINS requests the floor to speak on a Point of Personal Expression and states:

"It was with regret that I tendered by resignation as Vice Chairman of the Finance Committee. There are many reasons for this action

because, directly put, I find it impossible to support the leadership of this Council when they chose not to support me. Let me make it perfectly clear. I am not upset with my colleagues in general, but with the President and the Majority Leader.

Since the beginning of this term, I have served on the Finance Committee with them in my capacity as Vice Chairman. The natural progression since I have been on this City Council has been for Committee members to move up, but there seems to be two sets of rules. Or perhaps, as evidenced in the 1960's the rules get changed mid-stream depending on the players.

It was okay for the President Pro-Tem to move up to President, but not for me to move from Vice Chairman to Chairman of Finance.

Despite a population in the City that is 1/3 people of color, there are no minority councilmembers that are head of any standing committees. In addition, there is no minority in a leadership position that has real power. The most we are offered is a deputy's position or a vice chairmanship as a consolation prize.

Regarding remarks in the newspaper article, I want it made clear that the comment about giving 100% is absolutely resented. Is it the President's suggestion that I would not? Additionally, since I owned and operated my own companies for 13 years, I believe my qualifications would certainly equal those of a person who has been in the "business field" for many years.

Regarding comments from the Majority Leader, I was never, and I stress NEVER told of his apparent willingness to resign his position as Majority Leader. Nor was that position ever offered to me.

Finally, let me say that my commitment is to my constituents and to the people of Providence. I will continue to do the best that I can for them in spite of the political B.S. that goes on in this council."

COUNCILMAN IGLIOZZI requests the floor to speak on a Point of Personal Expression and states:

"Madam President, it saddens me to hear those kinds of comments tonight, they are particularly distasteful, inaccurate, and particularly repugnant, especially as a result of the caucus action tonight, perhaps tonight, the work might be hypocritical. But, to say the least, unfortunately, there have been a lot of elections on this Council many times where people have not got the office that they had sought. Councilwoman Josephine DiRuzzo had indicated on numerous occasions about her attempts not only to seek the Presidency but also re-election as President Pro Temp and although we have been on different sides of the issue, on her election, I think that we have put those differences aside and have moved on. It is unfortunate perhaps that my colleague, Mr. Rollins, who I do respect and appreciate should not focus on the excuse of why he didn't have the votes but perhaps should just move forward and look for the best on the Council.

Again, it is particularly repugnant under these circumstances when people try to use excuses, perhaps race as an excuse for a decision that was purely political. As I indicated, I was torn between two people who supported me both Councilwoman Nolan and Councilman Rollins and I had to make a difficult decision. Sometimes you have to make difficult decisions. I made that difficult decision and I stand by it and it has nothing to do with color or race or creed. So, it is sad to hear these kinds of comments."

COUNCILWOMAN DiRUZZO requests the floor to speak on a Point of Personal Expression and states:

"It really saddens me to hear the comments that Councilman Rollins just made and I'm really sorry to hear that because we, those of us who have tried to win elections on the Council that

feel that we deserved to win the election on the Council have tried to accept decisions of this Honorable Body with grace, and with the vision toward unifying the members of this City Council for the betterment of not only this Honorable Body but for the betterment of the Citizens of this City.

I don't like to hear one of the members that have been elected saying that it is for reasons of color. I don't believe in that, I don't see any color when I look at you John. I look at you as my brother, I look at women who sit in this Council as my sisters, the way that God intended it to be. I never did in the ten years that I served on the School Board and it is too bad because tonight, I in caucus, had indicated that we do not have any minorities on the Leadership and you had the opportunity to support one of your color and you chose not to and I don't like bringing this up, but I have to because of the comments you have just made.

I don't think that it is fair to anyone on this Council and I don't think it is fair to the members of the Finance Committee nor do I think it is fair to the person who was chosen to serve as Chairman of the Finance Committee because she has served on the Council with distinction and she represents people of color, as well.

So, I don't think it is appropriate and I am going to suggest that you accept what has happened with you, as Vice-Chairman of the Finance as graciously as I accepted the fact that I wanted to become Council President Pro Temp again after 14 years on the Council and 10 years on the School Committee that this Council chose not to elect me as President Pro Temp and I think I accepted that with grace and it is okay with me because my colleague now serves as President Pro Temp and I serve as that token you mention, as Deputy Majority Leader. But, that is fine with me, because I still know that I am in a leadership capacity and whether or not I am serving in this position or not, I am still elected by the people to do the best for them and I have a vote on the City Council.

You have not lost that. You still remain on the City Council and I think that you should wish the person who has become Chairman of the Finance Committee the very best of luck and continue to serve on the Finance Committee and do the very best that you can to cooperate with everyone. Let the bygones be the bygones and let the past be the past. You have the future to look forward to. So, we still have a lot of work to do and I would like to see us do it in harmony."

PERSONAL EXPRESSION

COUNCILMAN DeLUCA requests the floor to speak on a Point of Personal Expression and states:

"Thank You Madam President, I would like to rise regarding the shocking news that there is a Referendum question on the Ballot this coming November asking the people to approve a 50 Million Dollar Bond to spend on City Streets and sidewalks, neighborhood Parks and Providence Plan.

That amount of information is basically all that the State Legislature's knew. Absolutely no details on for what, how much, what percentages, for what. That is all the information that the

Legislature knew at the request of the Mayor who said "ok, go ahead, put it on the Ballot".

I went through wholly hell for two months trying to put a question on the Ballot. Took it all the way to the Supreme Court and couldn't do it. Yet the Mayor can send a document . . . a brief note to the Legislature saying that we want a \$50 Million Dollar Bond to do some sidewalk repairs, some street repairs, some parks and finance the Providence Plan a little further. Not ever asking the City Council to support it, not ever giving any detail or asking for any input before it even went to the State House, the Legislature has no idea whether or not the City Council is aware of this, or is in support of it,

or against it, or what the feeling of the Council is, and just goes ahead and passes this referendum to vote on the ballot. I find it very insulting that the State Legislature would disregard the City Council, that a resolution wasn't accompanied and didn't request one. Didn't even make a call. I don't know what committee dealt with that, but they should have at least made a call to the City Council office and asked for an opinion on whether or not there was support of this issue, or if there was a knowledge of this issue. I think the referendum is so vague that without it being in full detail, and without Council support, it looks to me like a bad thing to approve. I am going to do what I can, and that's very little, I am only a little guy, to not support that referendum and

to make sure that it fails. I feel that leaving \$15 million dollars hanging with question marks all around it is just an opportunity for misuse of tax dollars, and I would certainly urge further discussion on the issue, that perhaps by November we could be appraised of what the plans are, we could come to an agreement of what will be and will not be. And perhaps I am open to having a change of heart on this issue, but knowing nothing about it, and just leaving it out there hanging, I think it's very dangerous, and I would hope that we not support it in this form at this time, unless there is further detail unveiled and talked about and agreed upon. Thank you."
