ORDINANCE SECOND READING

The Following Ordinance was in City Council October 2, 2003, Read and Passed the First Time and is Returned for Passage the Second Time:

An Ordinance in Amendment of Section 16-97 of the Code of Ordinances of the City of Providence, Entitled "Machinery, Equipment, Fans and Air Conditioning, Wherein the operation of Leaf-Blowing Equipment shall be limited to specified days and times.

Be it ordained by the City of Providence:

Sec. 16-97. Machinery, equipment, fans, and air conditioning.

It shall be unlawful for any person to operate any machinery, equipment, pump, fan and air conditioning apparatus, or similar mechanical device in any residential neighborhood so as to exceed fifty (50) dBA between the hours of 8:00 p.m. and 7:00 a.m. or so as to exceed fifty-five (55) dBA between the hours of 7:00 a.m. and 8:00 p.m., or at any hour when the same is audible to a person of reasonably sensitive hearing at a distance of two hundred (200) feet from its source, provided, however, that it shall be unlawful for any person to operate any leaf-blowing equipment except between the hours of 10:00 a.m. and 8 a.m. on weekdays and between the hours of noon and 6:00 p.m. on Saturdays.

This ordinance shall take effect upon passage.
