
NOMINATION OF JUDGE OF PROBATE COURT



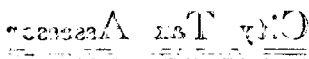
