ORDINANCE SECOND READING

The Following Ordinance was in City Council March 2, 1995, Read and Passed the First Time and is Returned for Passage the Second Time:

An Ordinance in Amendment of the Code of Ordinances of the City of Providence Section 16-3, entitled: "Disorderly and Indecent Conduct", as Amended.

Be it Ordained by the City of Providence:

Section 1. That Section 16-3. of the Code of Ordinances of the City of Providence entitled: "Disorderly and indecent conduct" is hereby amended as follows:

Section 16-3. Disorderly and indecent conduct.

Any person who engages in conduct which violates any of the following subsections thereby commits disorderly conduct.

(a) Any person who shall act in a threatening, violent or tumultuous manner toward another whereby any person is placed in fear of safety of his life, limb or health or the property of any person is placed in danger of being destroyed or damaged; or

(b) Any person who shall, in a public place or near a private residence that he has no right to occupy, disturb any person by making loud and unreasonable noise which under the circumstances would disturb a person of average sensibilities; or

(c) Any person who shall in a public place use "fighting words" or offensive language or words which by their very utterance inflict injury or are likely to provoke a violent reaction on the part of the average person so addressed; or

(d) Any person, who alone or in concert with others, obstructs any place ordinarily used for the passage of persons, vehicles, or conveyances or otherwise engages in conduct which obstructs or interferes physically with a lawful meeting, procession or gathering; or

(e) Any person who shall assemble or congregate with another or others for the purpose of causing, provoking, or engaging or who shall cause, provoke or engage in any fight or other

riotous conduct whereby the life, limb, health or property of another is endangered; or

(f) Any person who shall throw any stone or other missile upon or at any person, vehicle, building, tree, sign or other public or private property; or

(g) Any person who shall urinate or defecate on or from any public street, alley, sidewalk or floor of any public building or building where the public gathers or has access, or who enters upon the private property of another and shall urinate or defecate on such private property; or

(h) Any person who enters upon the private property of another and looks into an occupied building structure located thereon without visible or lawful business with the owner or occupant thereof.

Any person found guilty of any violation of this section shall be punished by a fine or not less than one hundred dollars (\$100.00) nor more than five hundred dollars (\$500.00) or by imprisonment of not fewer than three (3) days nor more than

thirty (30) days or by not less than ten (10) days nor more than thirty (30) days of voluntary community service.

Section 2. This Ordinance shall take effect upon its passage.

PERSONAL EXPRESSION

COUNCILWOMAN WILLIAMS request to Speak on a Point of Personal Privilege, and states:

"First of all I would like to wish all of you a happy St. Patrick's Day and a happy St. Joseph's Day. Unfortunately I will not be able to attend the celebration tomorrow morning. I say this as a protest to the many parties which are held during the day at City Hall, which most of us, who have full time jobs can't attend. My hours at the school system vary between 8:00 and 3:00, sometimes 8:30 to 3:00, and it's very difficult because of the demands of my job to get out of the system. What I would like to suggest, publicly, is that the time of celebrations be changed. I would have to say that I resent the fact that City employees are taking time out of their work to party during the day. I don't see why the celebrations are not at the end of the day, for example 4:00 to 5:00 p.m., so they would have a half hour, they might stay on and take a half hour from their own time. I think we need to stop

where the city is being made to spend money on things like these. For example, spending money on newspaper ads, letting the whole city and the state know that City Hall is having a St. Patrick's and St. Joseph's Day celebration, I certainly think in the spirit of these holidays they should be recognized, but I really think 10:30 in the morning, to open City Hall to people, to anyone to come in, it's a very nice gesture, but who is paying for this. Who is paying for these many parties. I just don't understand it. I think that given the fact that we are running into a deficit that we are talking about the many deficits that we are anticipating at the end of this fiscal year and into the next fiscal year that we have to start tightening our belts. We can't keep going along as if the city is not running out of money, and as if the city isn't in a financial dilemma. So often my colleague, Councilman DeLuca compares the city to a family, and when the income in a family is diminishing, that it would have to tighten its belts, and he said that very often. I'm just making a plea, again, to all of us, we are all concerned

about this, we need to look at this. We need to look at this incidentals. I'm not trying to be a party pooper, but we have to be serious about this. We are a city that is in distress right now, and we have to let everyone know that we are willing to make sacrifices in order to help the taxpayers,

and we are taxpayers. I just wanted to bring that up at this time and express my protest of all of these parties."
