## CHAPTER 1981-60

No. 685 **AN ORDINANCE** IN AMENDMENT OF SECTIONS 21 AND 22 OF CHAPTER 1981-40, EFFECTIVE JULY 20, 1981, ENTITLED: "AN ORDINANCE ESTABLISHING THE CLASSES OF POSITIONS, THE MAXIMUM NUMBER OF EMPLOYEES AND THE NUMBER OF EMPLOYEES IN CERTAIN CLASSES IN THE CITY DEPARTMENTS", RELATIVE TO DEPARTMENT OF BUILDING INSPECTION, AS AMENDED.

*Approved* November 27, 1981

*Be it ordained by the City of Providence:*

SECTION 1. Sections 21 and 22 of Chapter 1981-40 of the Ordinances of the City of Providence, effective July 20, 1981, is hereby amended to read as follows:

SECTION 21. The number of employees in the Department of Building Inspection-Administration shall not exceed seventeen (17). There shall be no more than:

- 1 Supervisor of Rehabilitation Services
- 3 Rehabilitation Specialist
- 1 Financial Specialist
- 3 Renewal Inspector III

- 1 Legal Secretary

SECTION 22. The number of employees in the Department of Building Inspection-Structures and Zoning shall not exceed ten (10). There shall be no more than:

- 1 Building Inspector III

SECTION 2. The following Sections shall be added:

SECTION 21A. The number of employees in the Department of Building Inspection-Code Enforcement shall not exceed fifteen (15). There shall be no more than:

- 1 Chief-Code Enforcement
- 1 Supervisor
- 1 Supervisor of Rehabilitation Services
- 2 Renewal Inspector III
- 5 Renewal Inspector II
- 5 Renewal Inspector I

SECTION 21B. The number of employees in the Department of Building Inspection-Prosecution shall not exceed eight (8). There shall be no more than:

- 1 Counsel-Building Inspection II
- 1 Counsel-Building Inspection I
- 3 Rehabilitation Specialist
- 1 Financial Specialist
- 1 Renewal Inspector III
- 1 Legal Secretary

SECTION 3. This Ordinance shall take effect upon its Passage.
