

In accordance with Section 21-26 of the City's Code of Ordinances, I am writing to request that the following requested contract awards be submitted to the City Council and the Finance Committee for approval.

- *Planning & Development* – Approval of a sole source contract in the amount of \$55,800 with Design by RI as a partner to assist the city with recruiting and mentoring arts and design-based businesses that are the beneficiaries of the Providence Design Catalyst Program.

Dear Mayor Elorza:

We are requesting the Mayor to approve, and the Board of Contract and Supply to authorize Providence Water to engage the services of Cox Business Services for \$140,880.00, to expand the bandwidths of data services at the newly acquired 125 Dupont Dr., Providence.

With the acquisition of Providence Water's new facility at 125 Dupont Dr. in Providence, the IT department performed an analysis of the current network incorporating the transition to running the additional newly acquired property at Dupont Dr. The results of the analysis considered the transfer of extremely large volumes of data from the two locations, located at 430 Scituate Ave. Cranston, and 552 Academy Ave. in Providence.

This request is for data lines, large data transfers, between all facilities and Dupont Drive, and communications for telephones at the new facility on the telephone server. Pricing is based on the MPA #308. This amount covers Providence Water's rapidly expanding communication and data needs and requires more extensions and monitoring connections associated with telephone and communications expansions, at our new Dupont Dr. facility.

Cox Communications is our current vendor, and has provided excellent service for over 15 years, at lower cost and exceptional customer service for our changing needs.

It is in Providence Water's best interest to engage the services of Cox Business services in an amount \$140,880.00. Funds are available in the Providence Water's General Fund 845-845-28003 account.
