Resolution approving the accompanying plat, entitled Dedication of Knowles Walkway, Mount Hope Renewal Project R. I., R-18, Providence Redevelopment Agency, Stanley P. Blacher, Chairman, et al, Scale 1" = 50.00' dedicating for walkway purposes certain tract or parcel of land situated between Evergreen Street and Grand View Street, shown as a cross-hatched area and designated by the letters A-B-C-D-E-F-G-H-A on the accompanying plan under the provisions of Chapter 987 of the Public Laws of 1913 and thereafter declared a public walkway to be repaired and maintained at the expense of the City of Providence.




DEDICATION OF KNOWLES WALKWAY (PORTION)
