RE: Request for abatement

With regard to Collector's Certificate #16, please be advised that the three items listed under account 64-065-930 relate to a motor vehicle excise tax bill leased to the City of Providence.

Under the current excise tax system, vehicles are assessed to the owner of record--in this instance Notarantonio Brothers, Inc.

However under the agreement between the city and the lessor, the lessee (the city) is required to pay any taxes assessed by the city, town and/or state. The lease agreement is a standard type agreement with the only unusual feature being the fact that it would be the city paying the city's own excise tax Bill if this abatement is not approved.
