No. **393** AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE

CHAPTER 666, BY APPROPRIATING THE SUM OF FORTY SIX THOUSAND (\$46,000) DOLLARS TO MUNICIPAL DOCKS, ITEM 7.

Approved May 8, 1953

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 666 of the Ordinances of the City of Providence as approved September 22, 1952, and entitled: "An Ordinance Making Appropriation of \$28,328,060.70 for the Support of the City Government for the Fiscal Year Ending September 30, 1953", as amended, is hereby further amended by appropriating the sum of Forty Six Thousand (\$46,000) Dollars to MUNICIPAL DOCKS, ITEM 7.

SECTION 2: The said sum of Forty Six Thousand (\$46,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Forty Six Thousand (\$46,000) Dollars.

SECTION 4: This Ordinance shall take effect upon its passage.

No. 394 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE

CHAPTER 666, BY ADDING THE SUM OF FOURTEEN THOUSAND (\$14,000)

DOLLARS TO THE APPROPRIATION CONTAINED THEREIN FOR CHAPIN HOSPITAL,  
ITEMS 1 and 5.

Approved May 8, 1953

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 666 of the Ordinances of the City of Providence as approved September 22, 1952, and entitled: "An Ordinance Making Appropriation of \$28,328,060.70 for the Support of the City Government for the Fiscal Year Ending September 30, 1953", as amended, is hereby further amended by adding the sum of Fourteen Thousand (\$14,000) Dollars to the appropriation contained therein for CHAPIN HOSPITAL, ITEM 1 and 5. The said sum of Fourteen Thousand (\$14,000) Dollars shall be apportioned as follows: ITEM 1 - \$12,000; ITEM 5 - \$2,000.

SECTION 2: The said sum of Fourteen Thousand (\$14,000) Dollars as thus added and appropriated shall be obtained by transferring a like amount from CHAPIN HOSPITAL, ITEM 0.

SECTION 3: This Ordinance shall take effect upon its passage.
