No. 678 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO ARTICLE II, SECTION 21-31 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: "SEALED BIDS TO BE SUBMITTED".

*Approved* November 27, 1981

**Be it ordained by the City of Providence:**

SECTION 1. Article II, Section 21-31 of the Code of Ordinances of the City of Providence, is hereby amended to read as follows:

Sec. 21-31. Sealed bids to be submitted.

All bids for work on materials, submitted pursuant to the provisions of this article, shall be submitted to the board of contract and supply in sealed envelopes or wrappers, which shall have endorsed thereon the title of the work, materials or supplies to which such bids relate, and further said bids shall have contained thereon, the written amount of the item bid, as well as the corresponding arabic numerals and the signature of the owner or owners of the firm submitting said proposal.

(a) Any bid submitted not in accordance with the above format shall be rejected by the Board of Contract and Supply.

SECTION 2. This Ordinance shall take effect upon its Passage.
