SECTION 1: Chapter 666 of the Ordinances of the City Of Providence as approved September 22, 1952, and entitled: "An Ordinance Making Appropriation of \$28,328,060.70 for the Support of the City Government for the Fiscal Year Ending September 30, 1953", as amended, is hereby further amended by adding the sum of Thirty Two Hundred (\$3,200) Dollars to the appropriation contained therein for RECORDER OF DEEDS, ITEMS 1 and 2. Said sum of Thirty Two Hundred (\$3,200) Dollars shall be apportioned as follows: ITEM 1 - \$700.00 ; ITEM 2 - \$2,500.

SECTION 2: The said sum of Thirty Two Hundred (\$3,200) Dollars as thus added and appropriated shall be charged to the General Fund from Funds Not Otherwise Appropriated.
