ORDINANCES SECOND READING

An Ordinance Amending the Appropriation Ordinance Chapter 1977-35 Approved July 18, 1977, by Appropriating a Sum Not to Exceed One Hundred Thousand Dollars (\$100,000.00) for the City of Providence Law Department, Special Items 3, for Claims Against the City of Providence.

Be it ordained by the City of Providence:

Section 1. Chapter 1977-35 of the Ordinances of the City of Providence, as approved July 18, 1977 and entitled: "An Ordinance Making Appropriation of \$108,255,372.79 for the support of the City Government for the Fiscal Year ending June 30, 1978, as amended" is hereby further amended by appropriating the sum of One Hundred Thousand Dollars (\$100,000.00) for the City of Providence Law Department Claims — Special Items 3, for claims against the City of Providence.

Section 2. The said sum of One Hundred Thousand Dollars (\$100,000.00) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like sum from Anticipated Revenues of the current fiscal year ending June 30, 1978.

Sec. 3. This Ordinance shall take effect upon its passage.

An Ordinance Amending Chapter 544 of 1951, by Changing from a C-1 Limited Commercial Zone to a C-4 Heavy Commercial Zone, Lots 342 and 344, as Set Out and Delineated on City Assessor's Plat 98; Said Lots being Situated at 650 Charles Street.

Be it ordained by the City of Providence:

Section 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended, and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations," is hereby further amended by changing from a C-1 Limited Commercial Zone to a C-4 Heavy Commercial Zone, Lots 342 and 344, as set out and delineated on City Assessor's Plat 98, as of December 31, 1968; said Lots being situated at 650 Charles Street, bounded and described as follows:

Beginning at a point on the westerly line of Charles Street at the northeasterly corner of Lot 342 on the City of Providence Assessor's Plat 98; thence southerly along the westerly line of Charles Street to the southeasterly corner of Lot 344 on the City of Providence Assessor's Plat 98; thence westerly bounded southerly by Lot 345 to the R-2 Zoning Division Line and the south-westerly corner of Lot 344 on City of Providence Assessor's Plat 98; thence northerly along the Zoning Division Line, bounded westerly by Lots

335, 336 and 337 to the northwesterly corner of Lot 342 on City of Providence Assessor's Plat 98; thence easterly along the northerly line of Lot 342, bounded northerly by Lot 341 to the north-easterly corner of Lot 342 on City of Providence Assessor's Plat 98; said point being the point and place of beginning.

Sec. 2. This Ordinance shall take effect upon its Passage.

Now, Therefore, be it Resolved, That His Honor Vincent A. Cianci, Jr., Mayor and the Honorable City Council do hereby proclaim the month of April, 1978, as "Voter Registration Month" in Providence, in recognition of this worthy and notable effort and pledge their support to make the April Registration Drive a success.

Resolution Requesting the Board of Canvassers and Registration to Appoint Deputy Registrars to Assist in Making "Voter Registration Month" a Success.

Whereas, April, 1978, has been designated as "Voter Registration Month" in all six New England States, and

Whereas, The people of Providence should be accorded every opportunity to register to vote, and

Whereas, In order to facilitate increased voter registrations, an outreach program sponsored by the Providence Board of Canvassers would be of great benefit to all of our Citizens.

Now, Therefore, be it Resolved, That the Providence Board of Canvassers, in conjunction with "Voter Registration Month" in Providence, be requested and memorialized by the Providence City Council to, pursuant to the power invested in said Board by the General Laws of the State of Rhode Island, appoint and commission Deputy Registrars for the purpose of Outreach Voter Registration in the following number and fashion:

A. Five (5) Deputy Registrars to be recommended by the President of the Providence League of Women Voters.

B. Five (5) Deputy Registrars to be recommended by the Chairperson of the Minority Caucus to represent all Minority interests.

C. Five (5) Deputy Registrars chosen by the Chairman of the Board of Canvassers to represent the public.

D. Five (5) Deputy Registrars to be recommended by the City Chairman of the Republican Party.

E. Five (5) Deputy Registrars to be recommended by the City Chairman of the Democratic Party.

Now, Therefore, be it Resolved, That all Twenty-Five (25) Deputy Registrars recommended shall meet all criteria of State Law for eligibility and shall be required prior to deputization, to attend a training course conducted by the Providence Board of Canvassers held at City Hall, at a time to be designated by the Board.

Whereas, The City of Providence deems it necessary and in the public interest (1) to develop a systematic approach to analyze the local economy, (2) to define development goals, (3) to determine project opportunities and (4) to formulate and implement a development program; and
