COLLECTION ATTORNEYS.

AUTHORIZING THE EMPLOYMENT OF TAX

Approved February 6, 1959

*Be it ordained by the City of Providence:*

Section 1. The City Collector, with the approval of the Finance Director and the City Solicitor, is hereby authorized and directed to employ attorneys at law to aid in the collection of personal property taxes due and payable to the City. The terms and conditions of employment, including compensation, shall be determined by the Finance Director. The City Council shall appropriate such sum of money as may be deemed necessary to pay for such services and for all other expenses to be reasonably incurred in connection therewith. Payment shall be made upon vouchers duly approved by the City Collector and the Finance Director.

Sec. 2. This ordinance shall take effect upon its passage.
